Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data is extracted one month after the end of the reporting period (on the first day of the month).

Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.

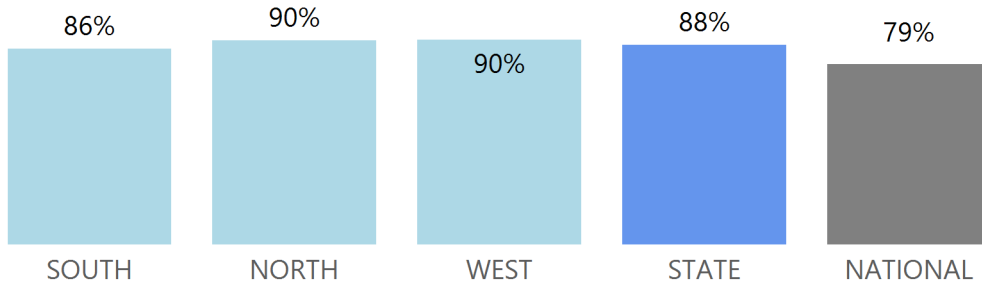

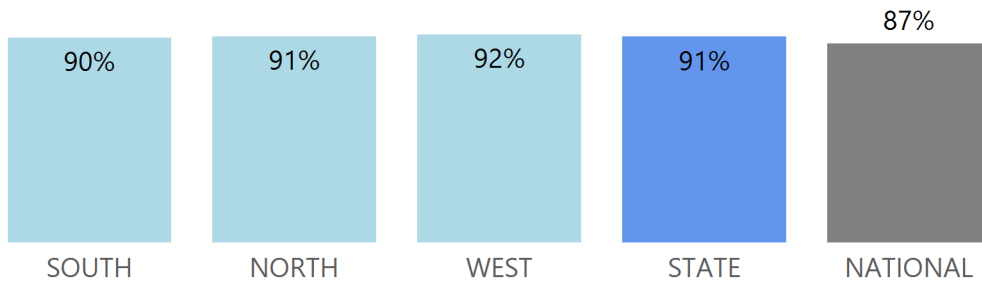
Safety at Home During the Night

(Survey respondents who answered "Safe/Very Safe".)



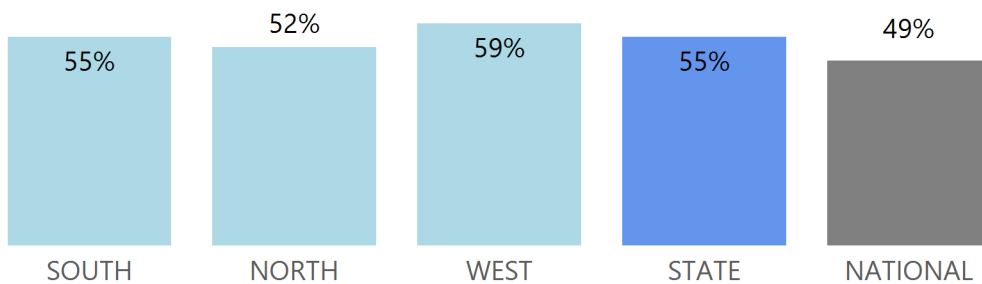
Safety In Neighbourhood During the Day

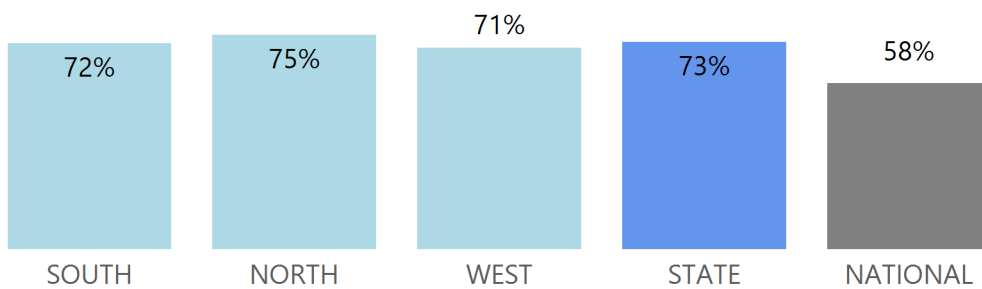

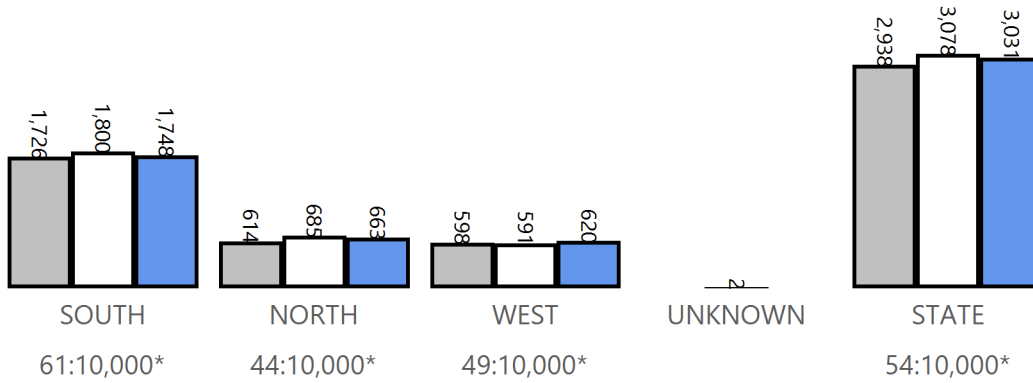

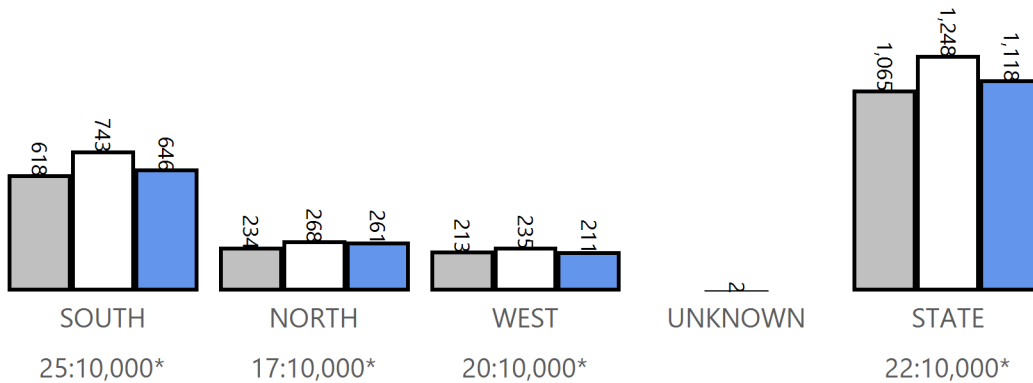

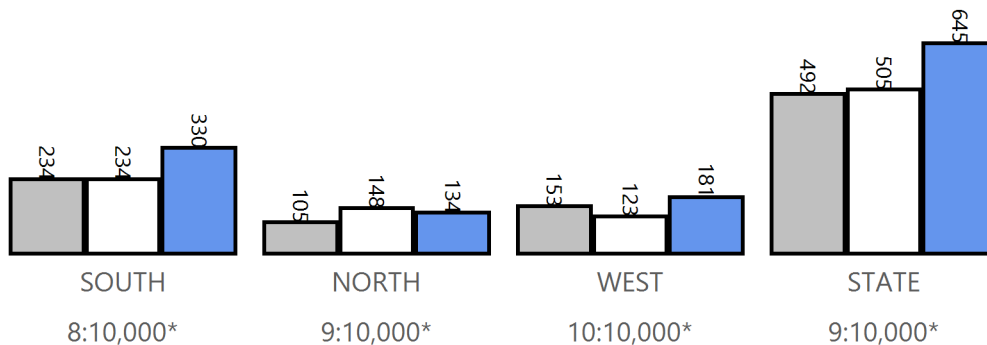

Public Order : Noise - August 2024

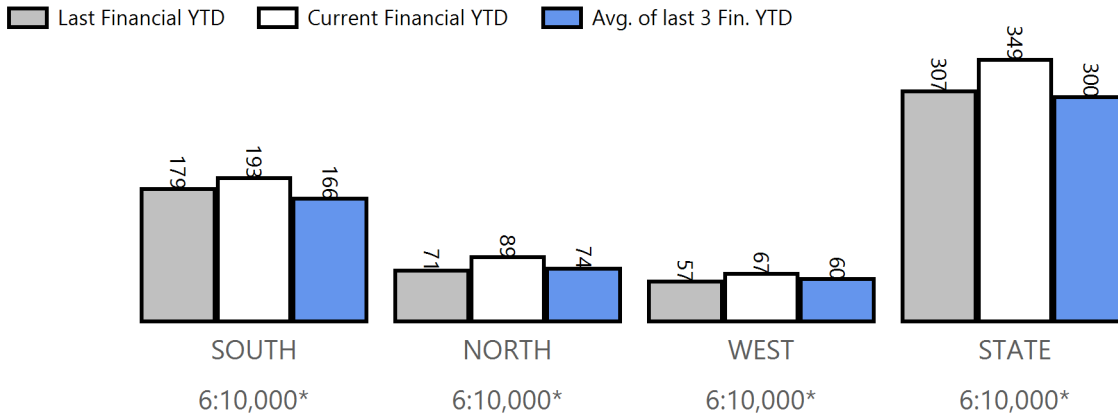

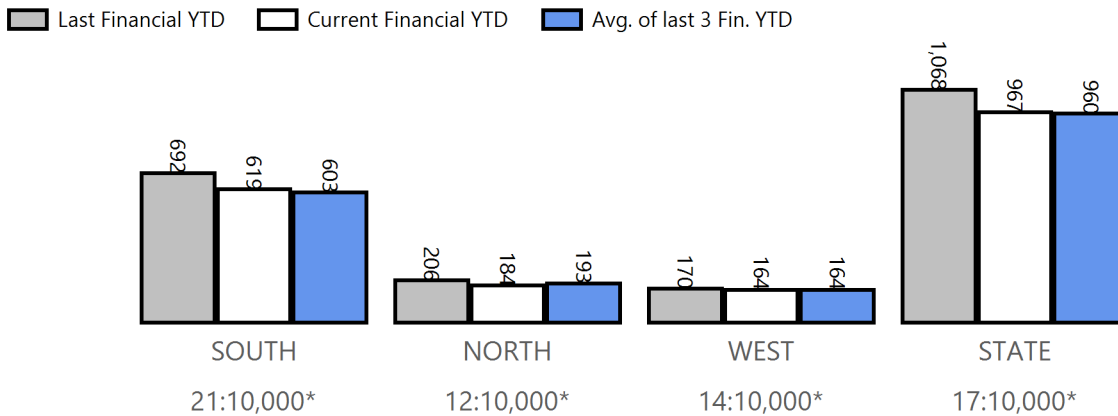
Public Order : Vandalism - August 2024

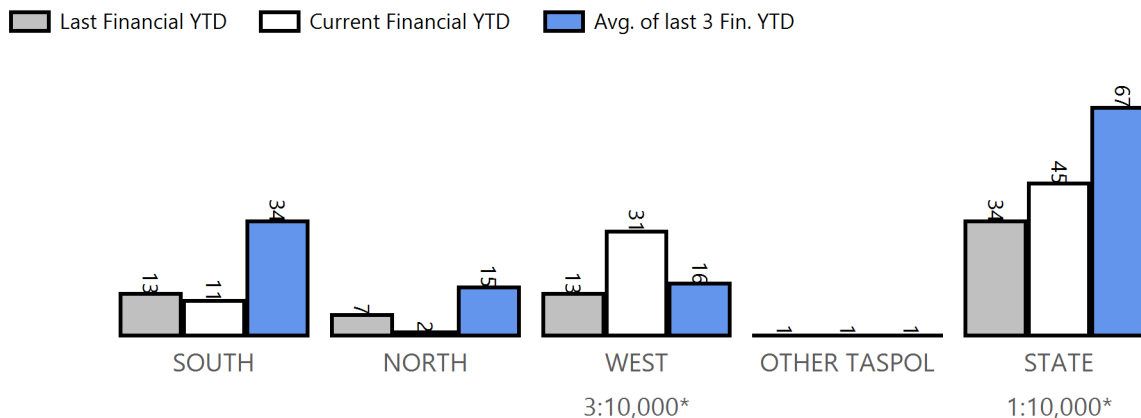
Public Order : Offensive Behaviour - August 2024

Liquor Infringement Notices - August 2024

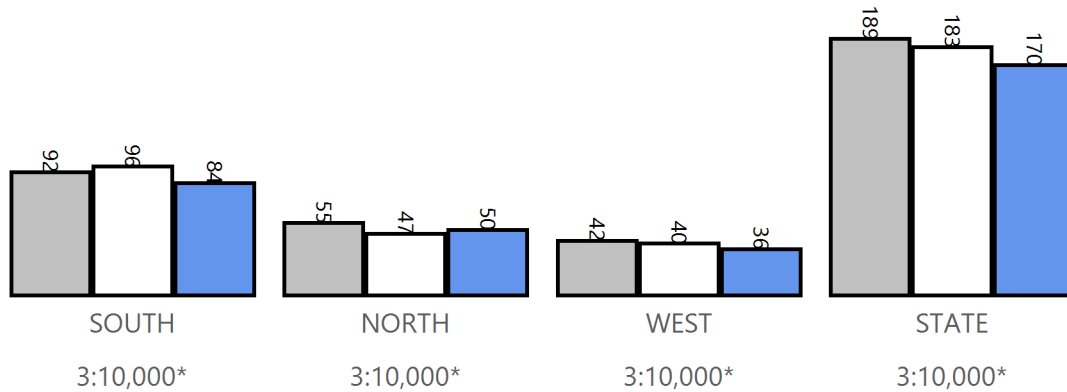

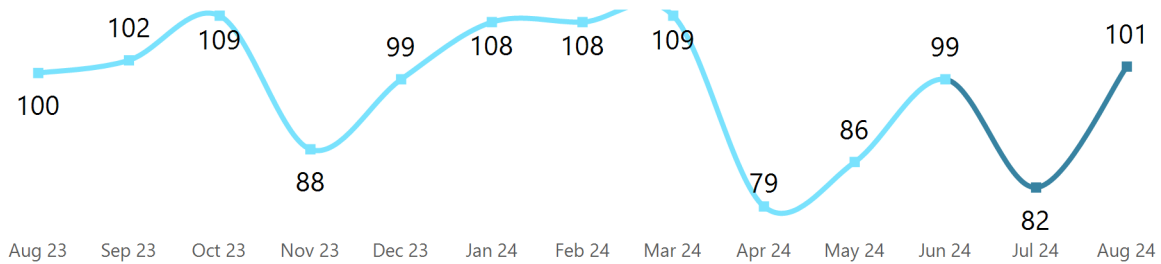

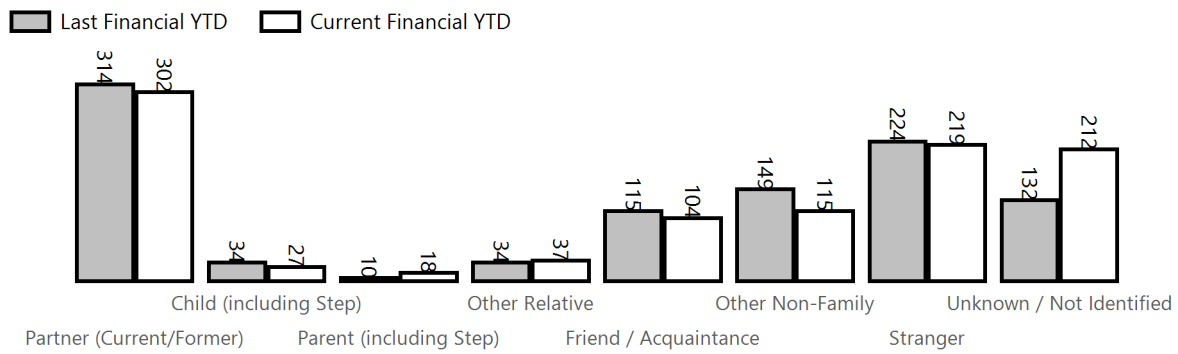

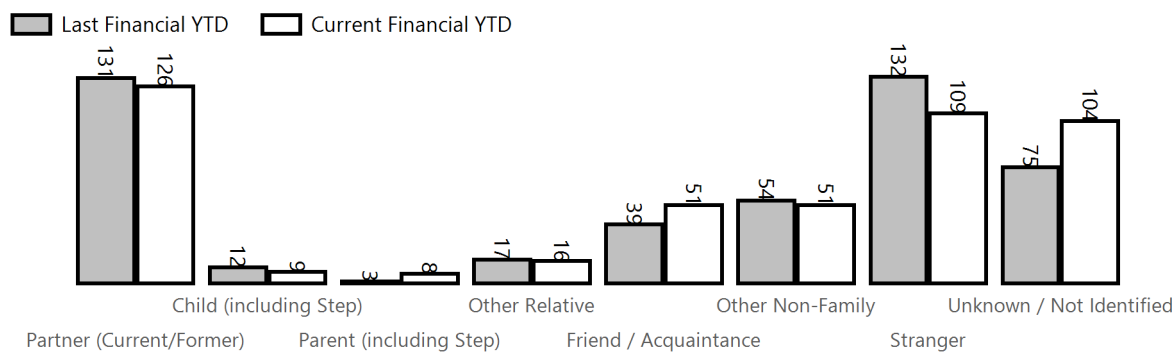

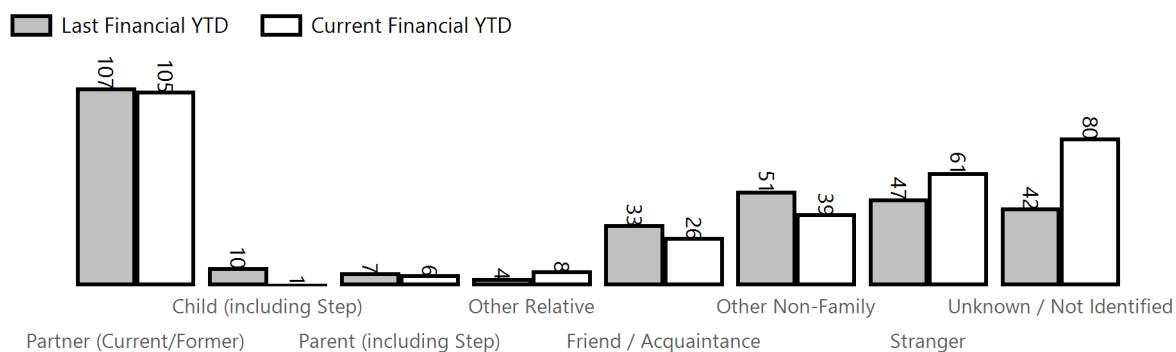

Total Person Offences - Victim Relationship - SOUTH



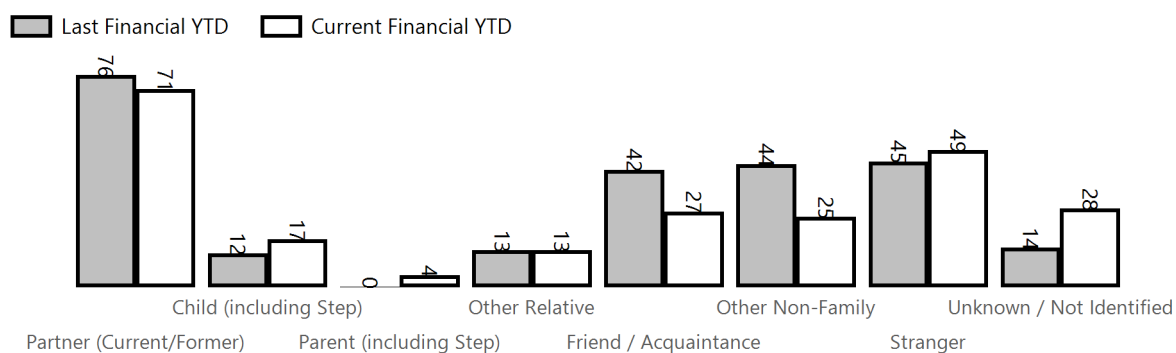

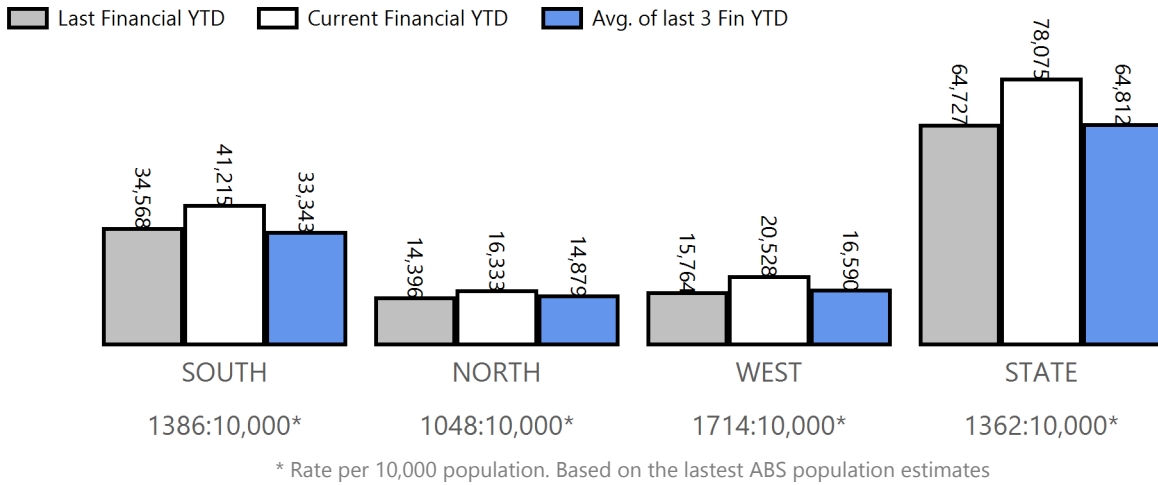

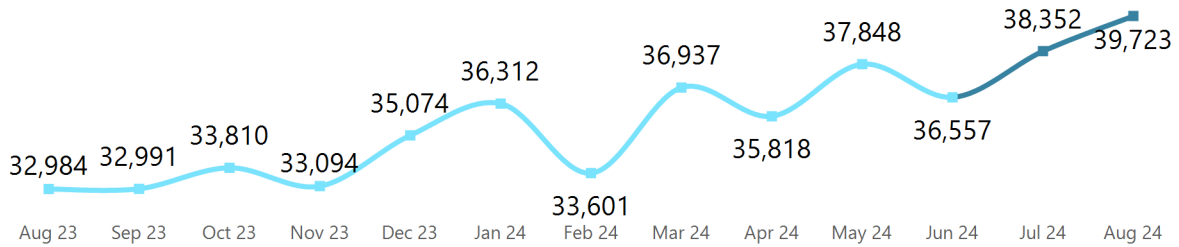

Uniform Police Patrol Hours - August 2024

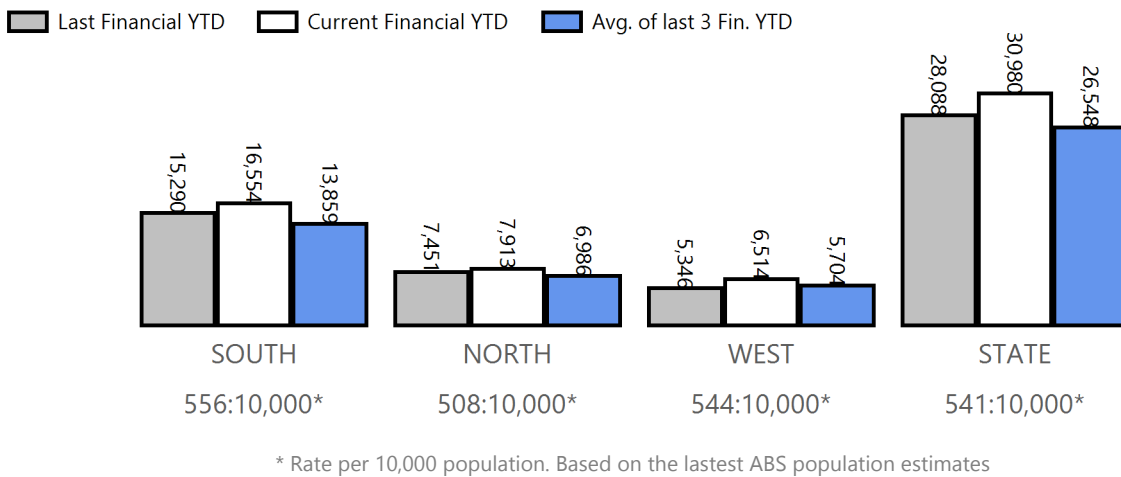


Uniform Police - Patrol Hours

Uniform Police Hours on Dispatch Tasks - August 2024



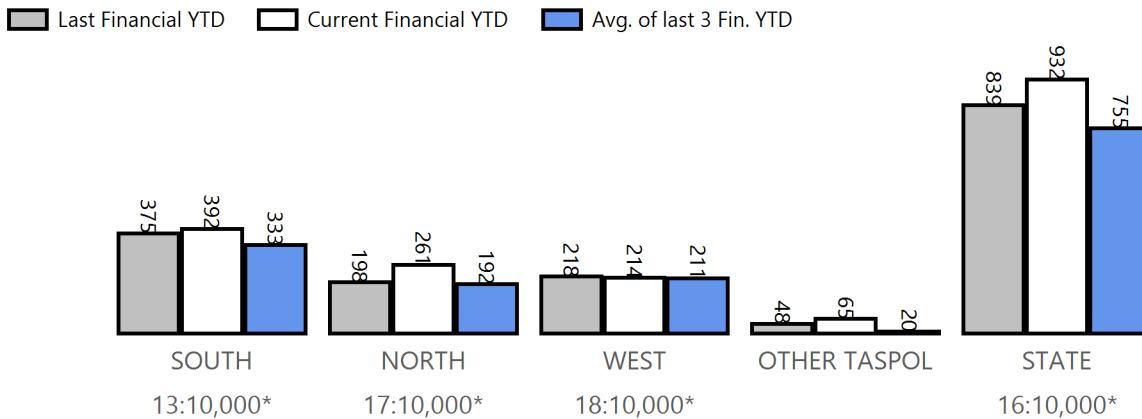

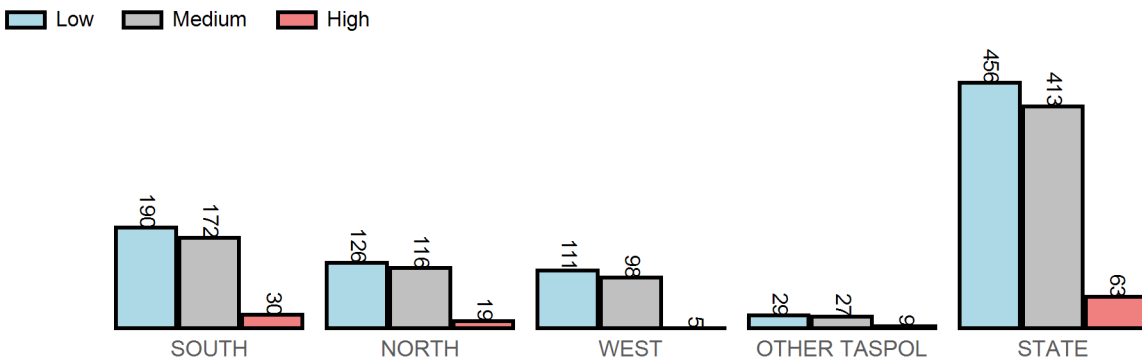
Family Violence Incidents - August 2024

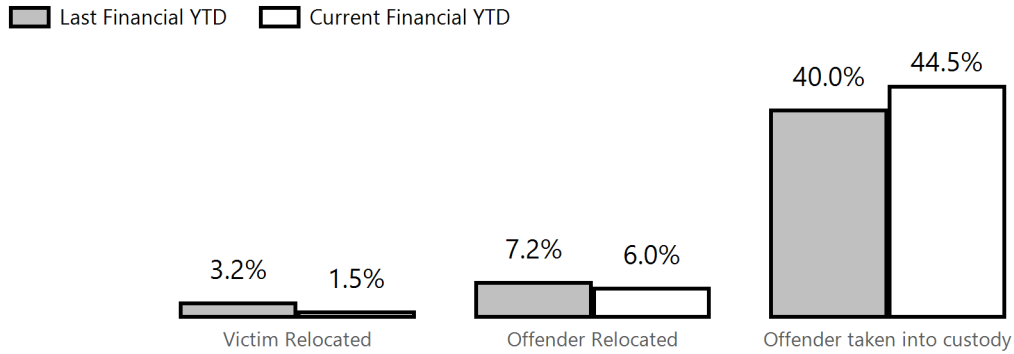

Family Violence RAST - Excludes Other and Argument Categories



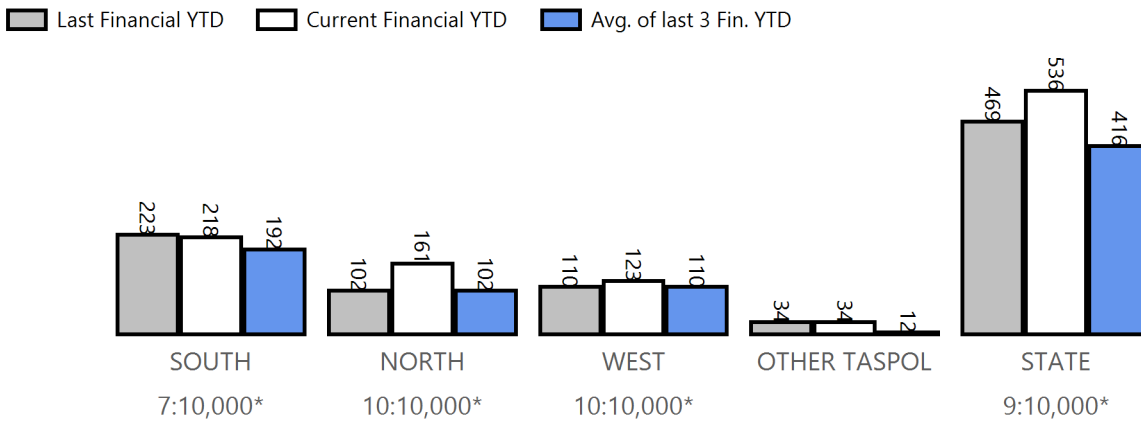

Family Violence - Action at Scene (Excludes 'Other' and 'Argument' categories)



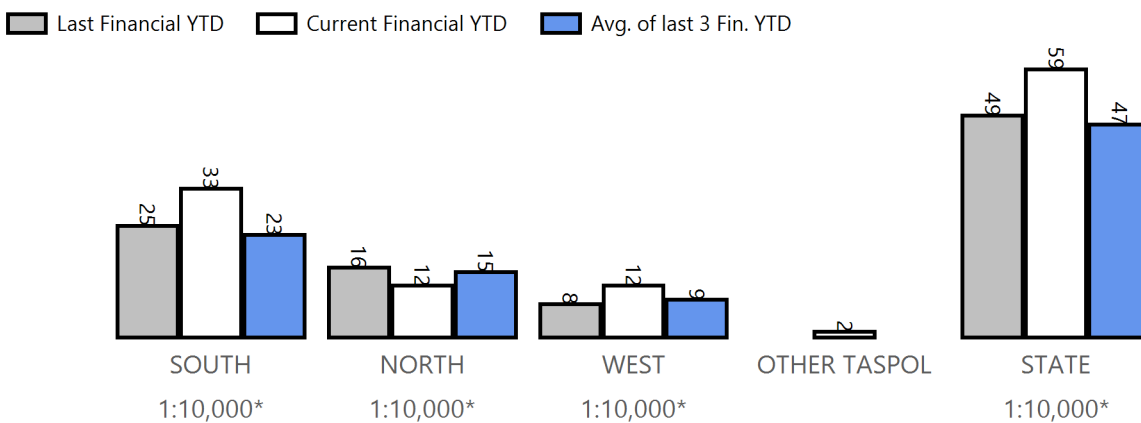

Family Violence Incidents: Weapons Present - August 2024

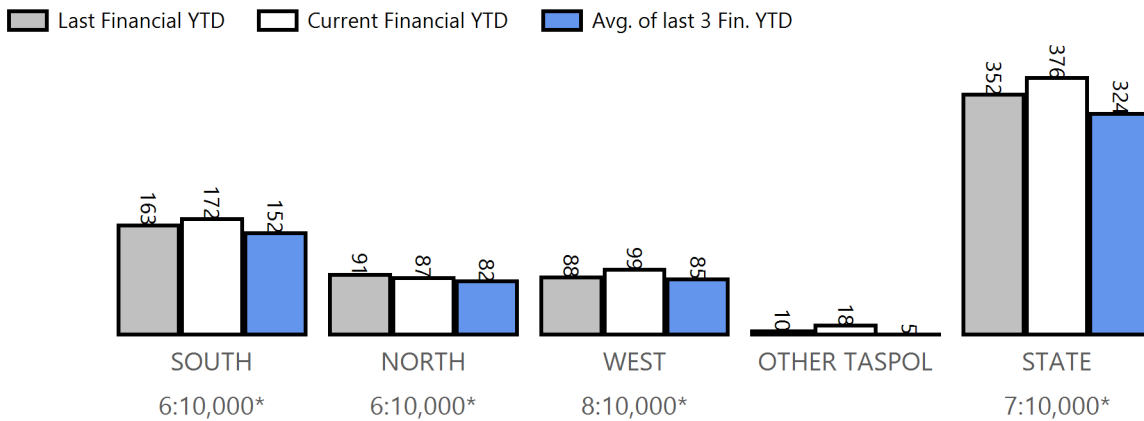

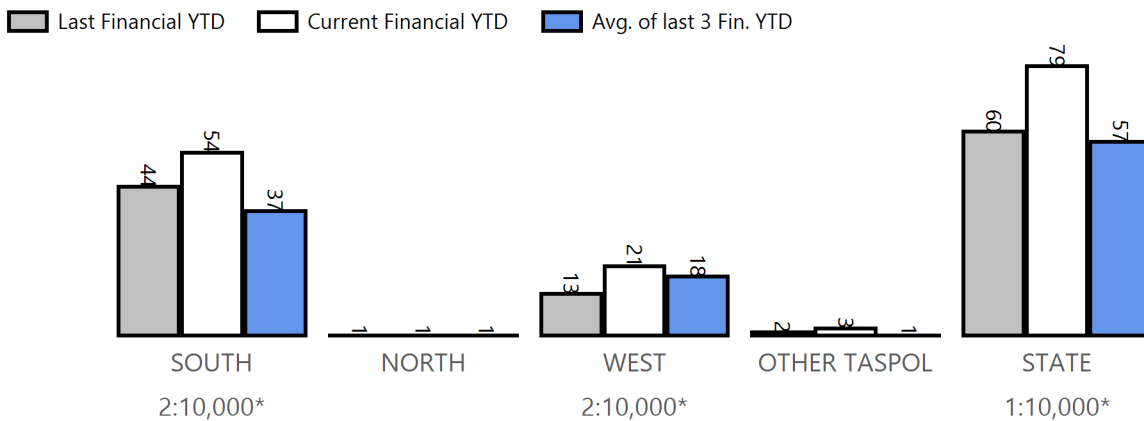
FV Incidents with Police FV Order Issued - August 2024

FV Incidents with FV Order Application - August 2024

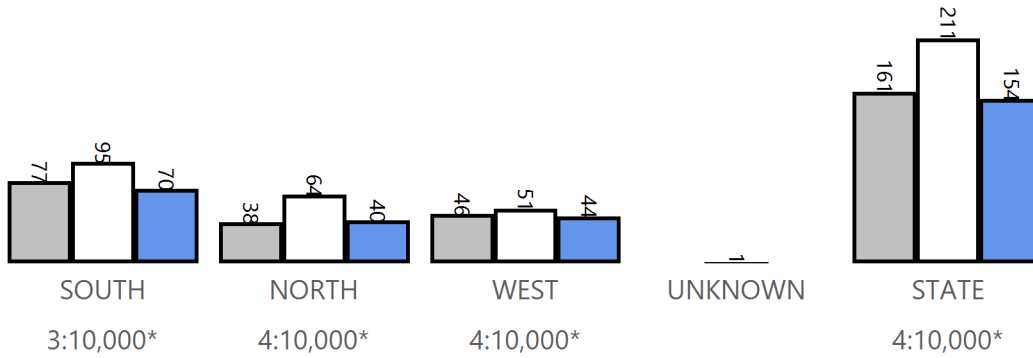

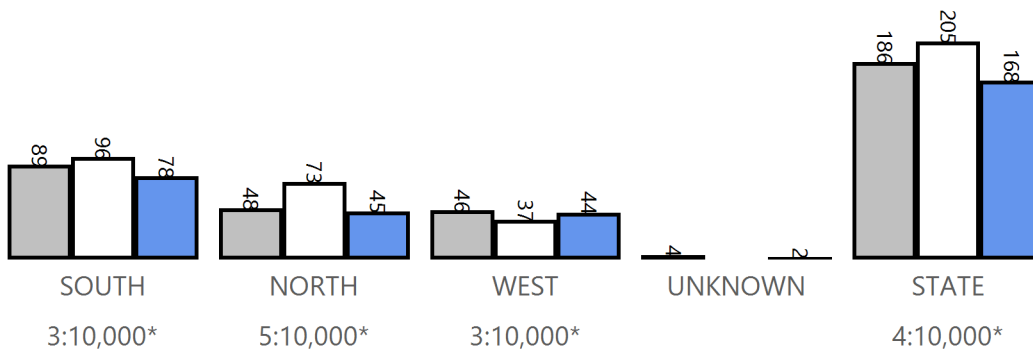

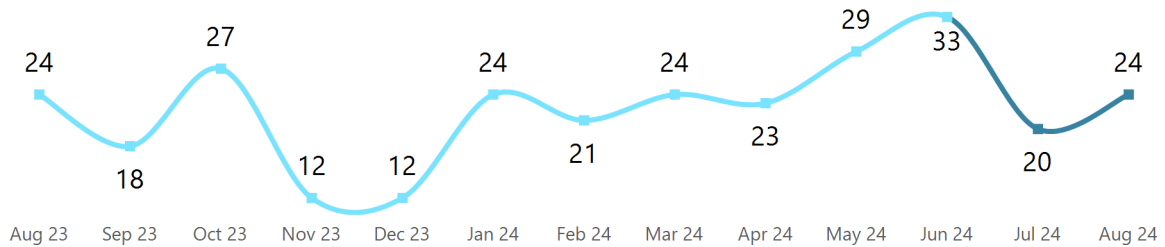
SMV : Recovered Fire Damaged - August 2024

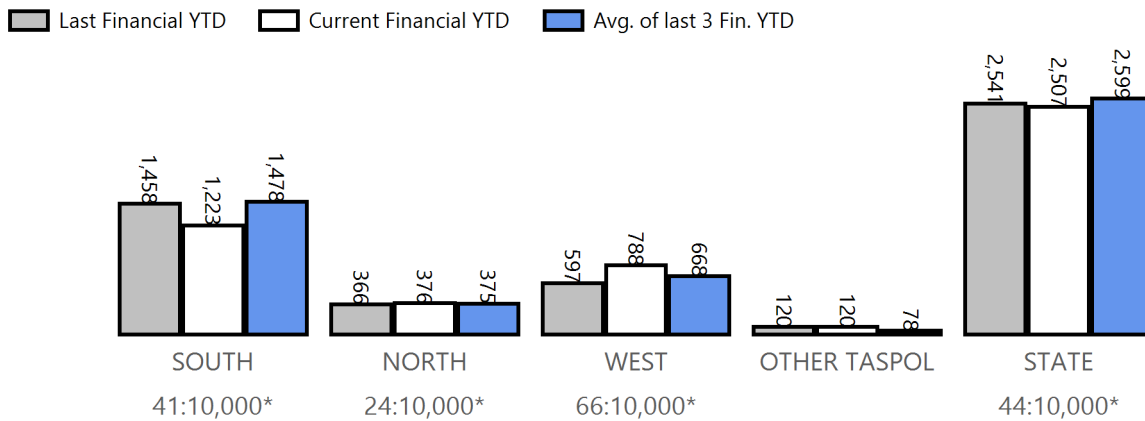
Intelligence Submission Occurrences - August 2024

Street Check Occurrences - August 2024

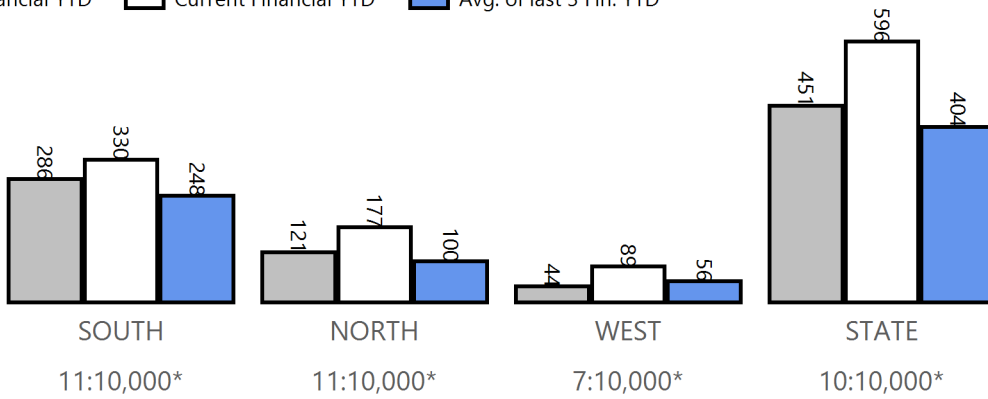

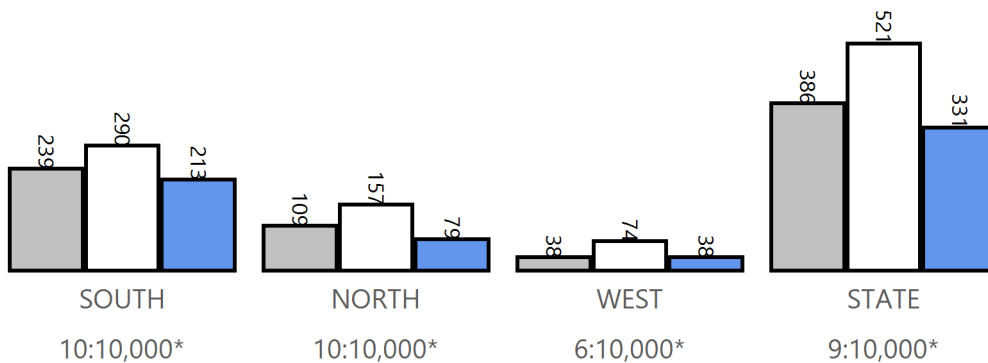

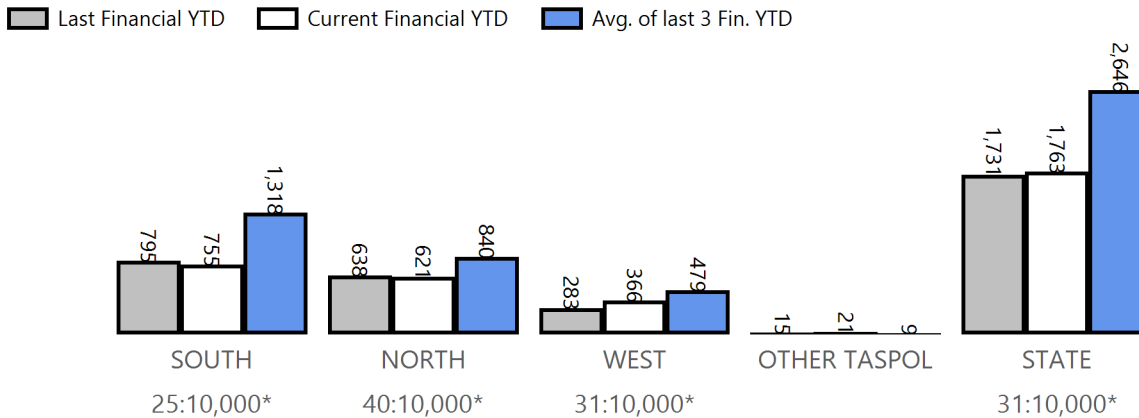
Speeding Offenders - August 2024

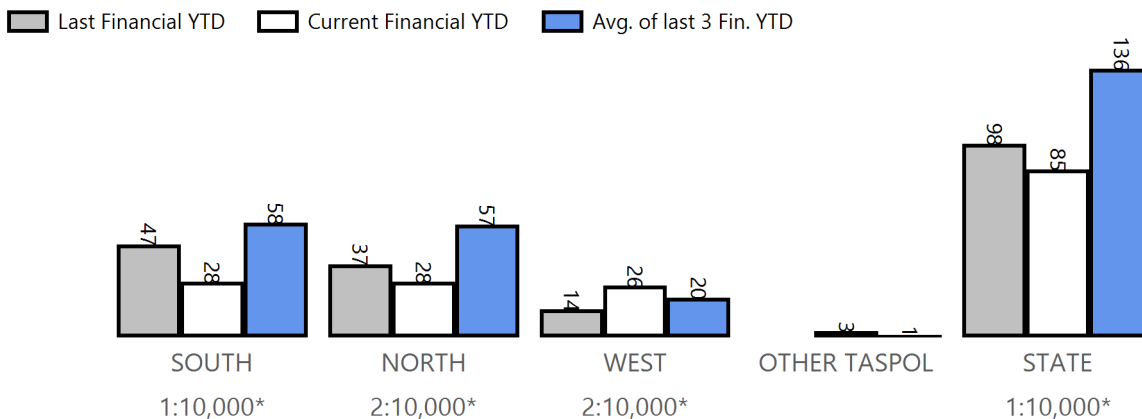
Speeding 15-29 km/h Offenders - August 2024

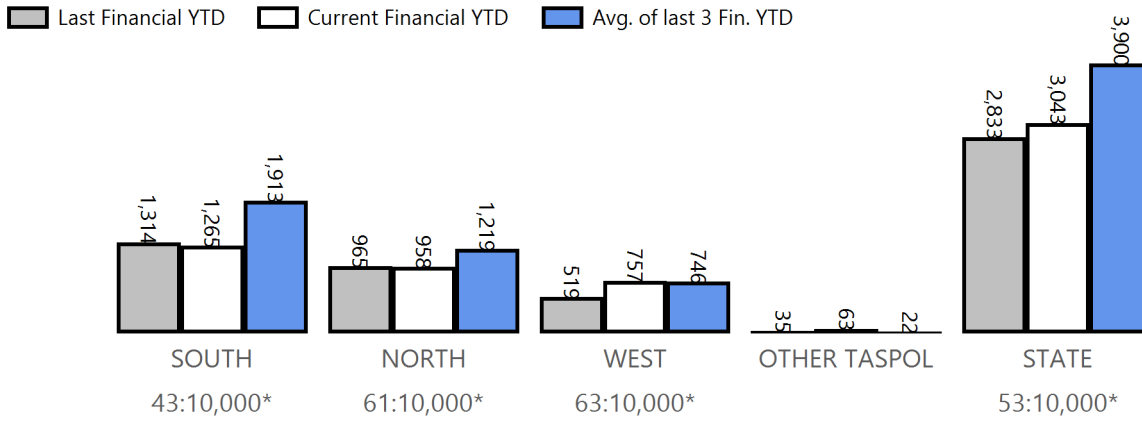
Speeding 30+ km/h Offenders - August 2024

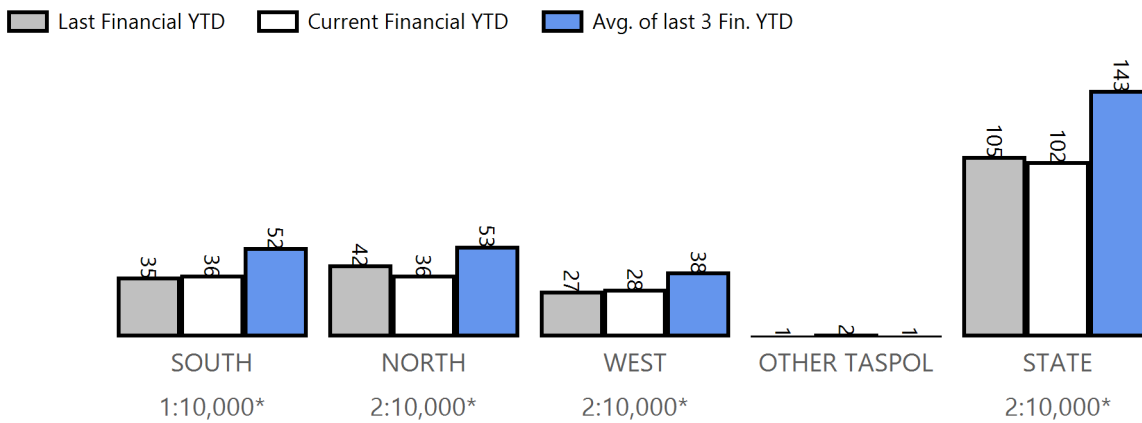
High Risk Traffic Offenders - August 2024

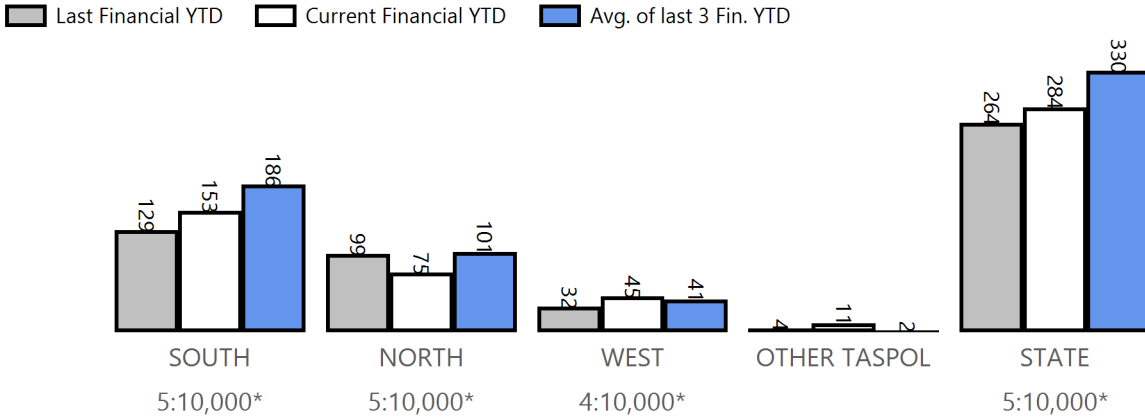
Seatbelt Compliance Offenders - August 2024

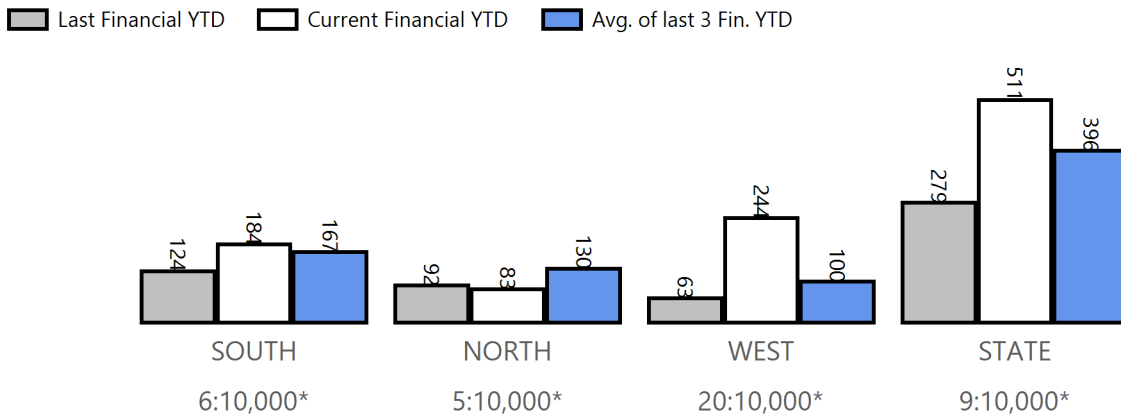
Mobile Phone Offenders - August 2024

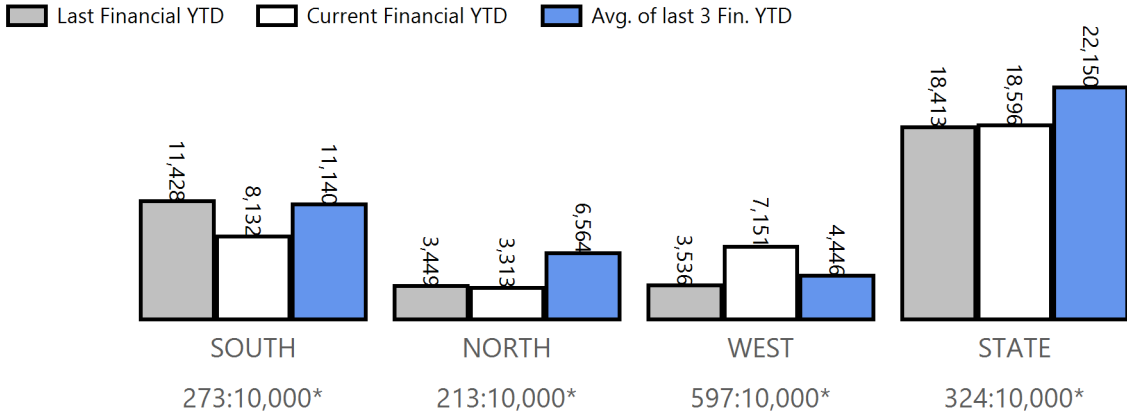
Vehicle Defect Notices - August 2024

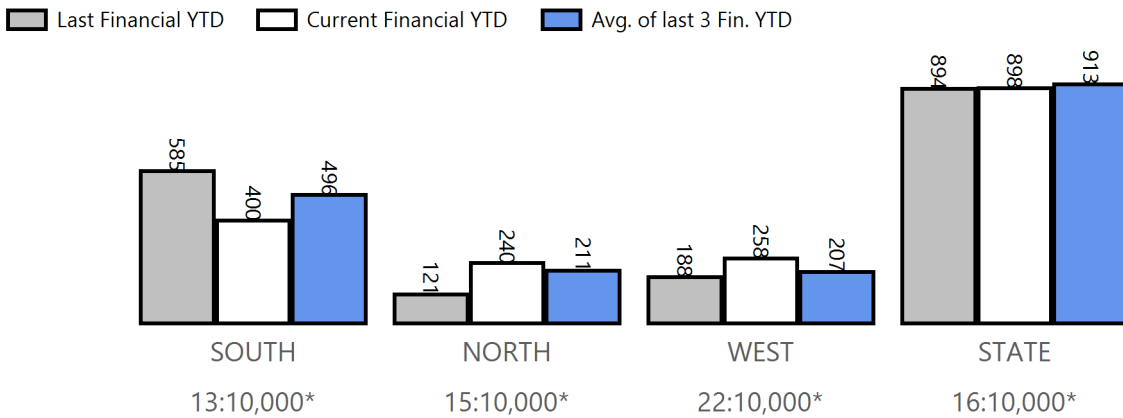
Random Breath Tests (Alcohol) - August 2024

Oral Fluid Tests (Drugs) - August 2024

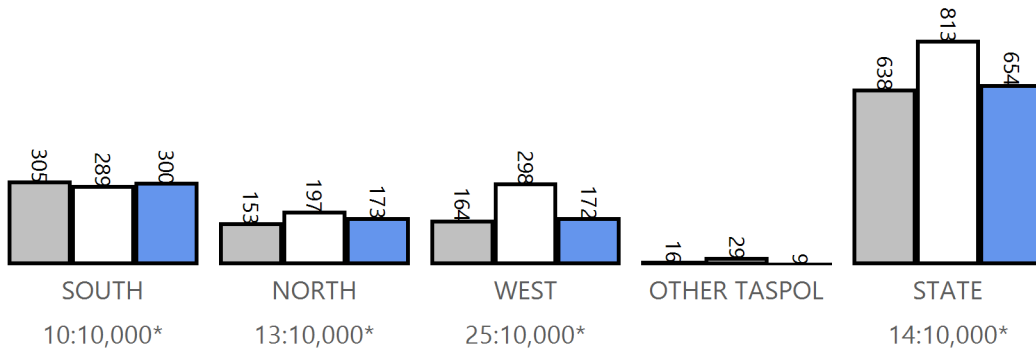

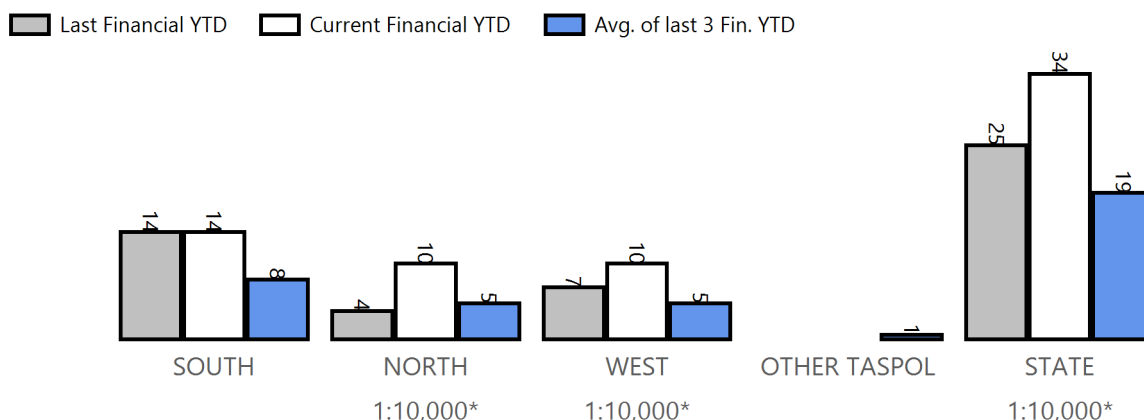

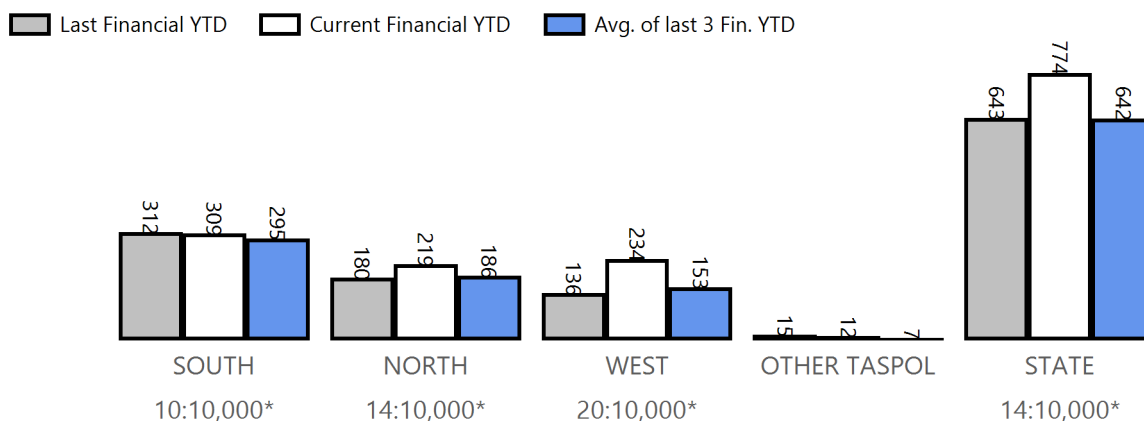
Dangerous and Reckless Driving Offenders - August 2024

Disqualified and Unlicensed Driving Offenders - August 2024



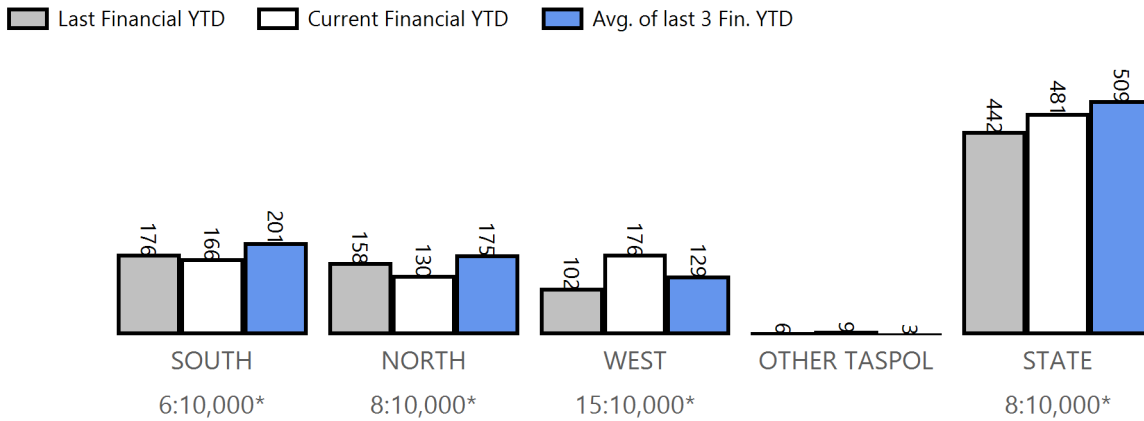

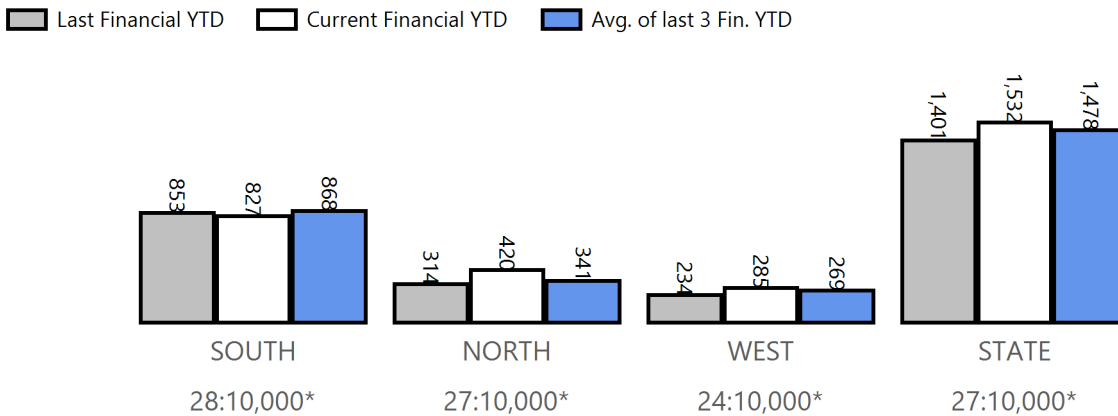
Unregistered Vehicle Offenders - August 2024

Vehicle Complaint Dispatch Incidents - August 2024

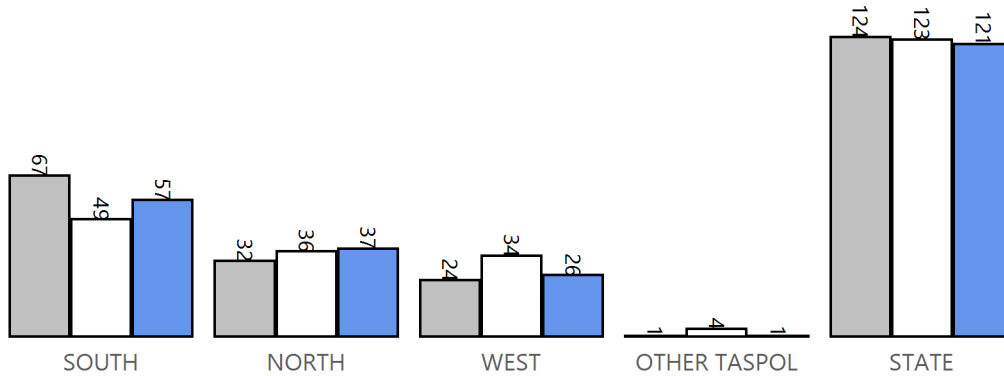

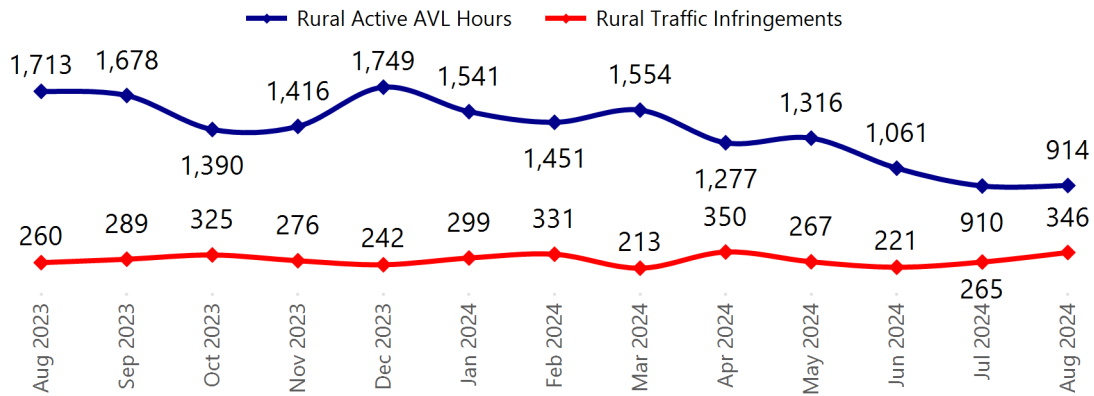

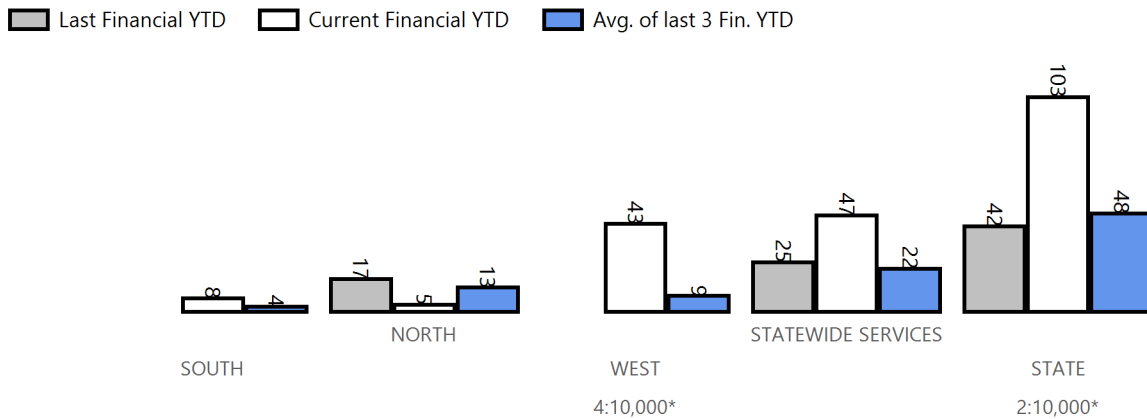

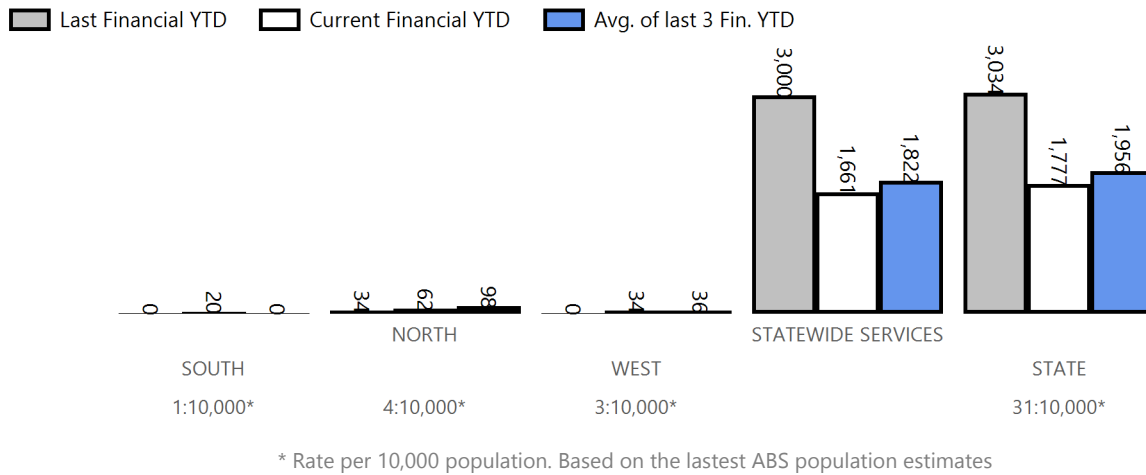

Total Marine Offenders - August 2024



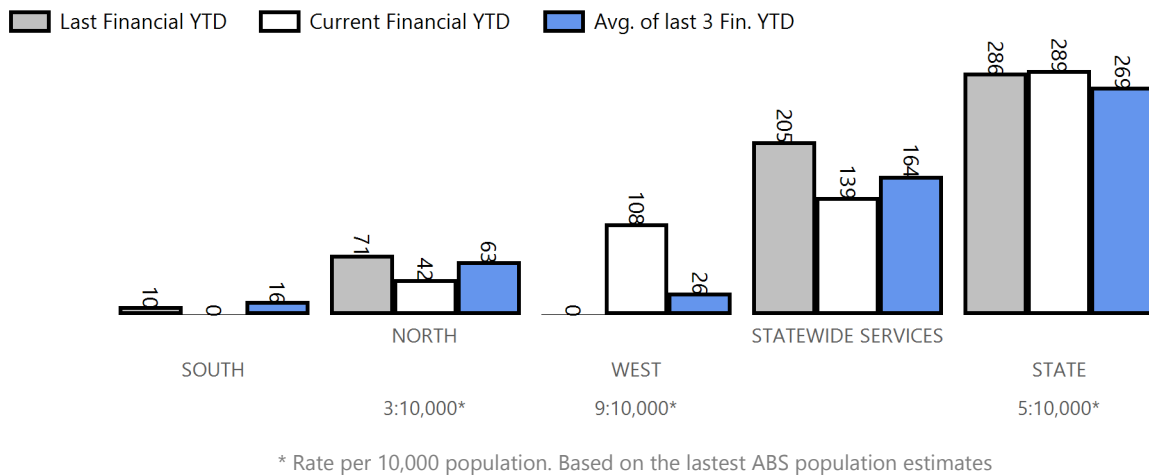

Sea Inspections (Vessel & Non-Vessel) - August 2024



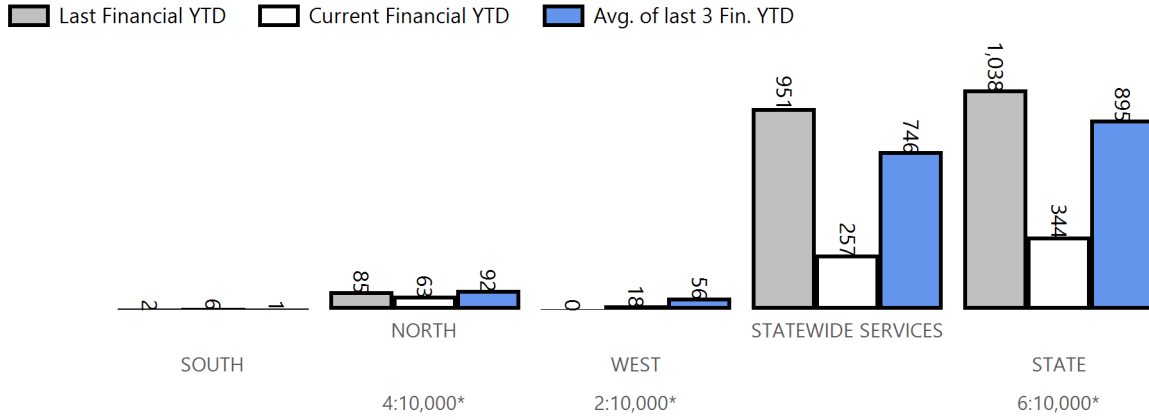
