Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data is extracted one month after the end of the reporting period (on the first day of the month).

Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.

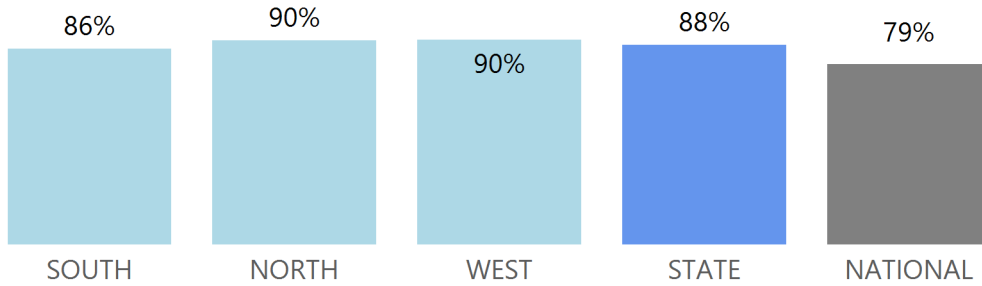

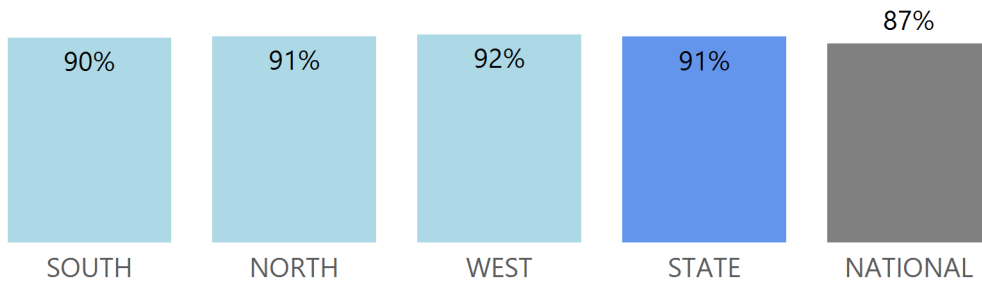
Safety at Home During the Night

(Survey respondents who answered "Safe/Very Safe".)



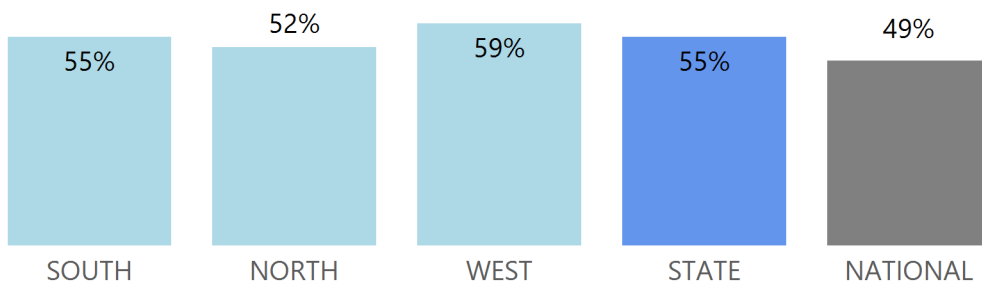
Safety In Neighbourhood During the Day

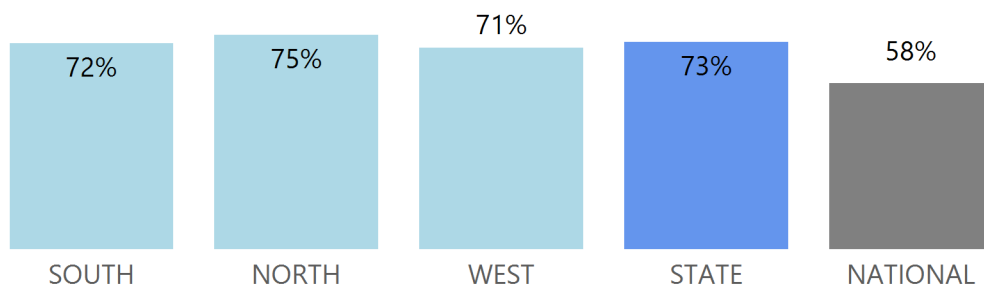

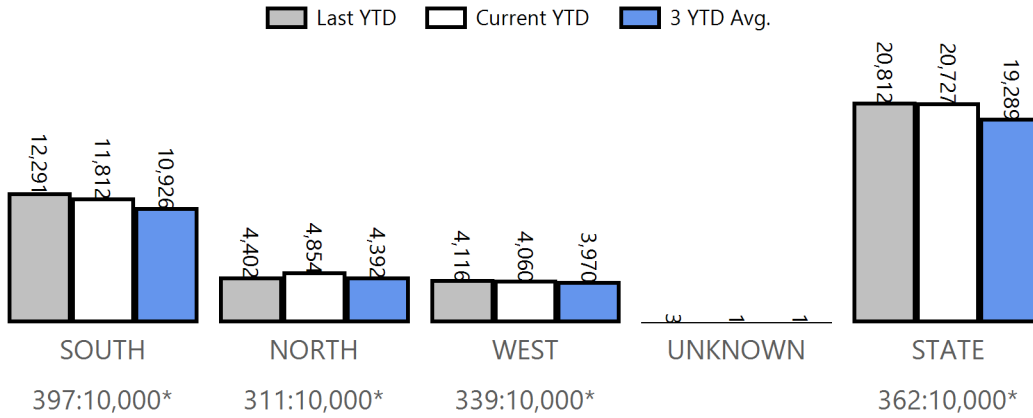

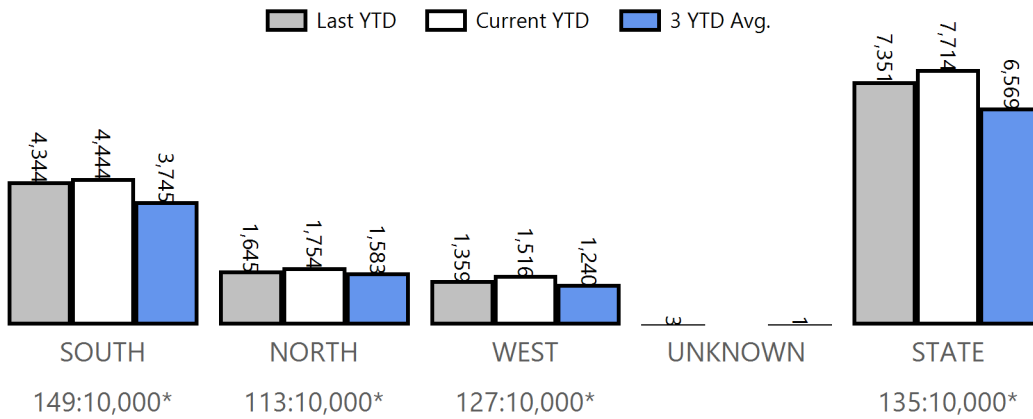
Public Order Incidents - June 2024

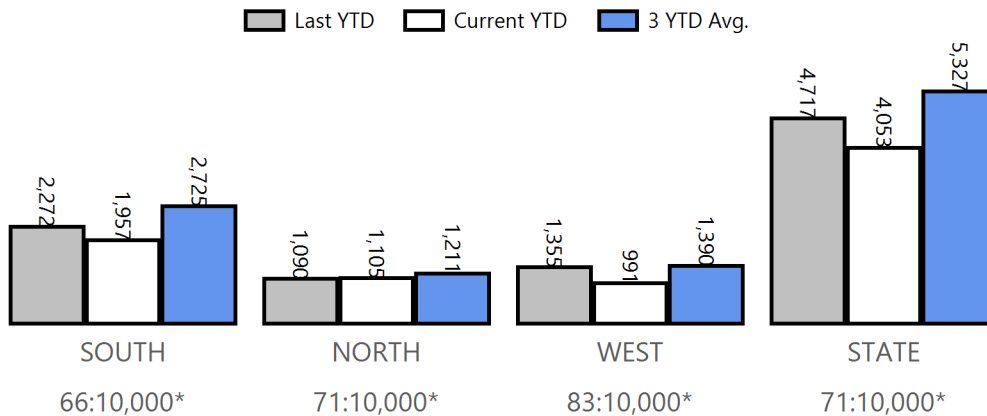
Public Order : Disturbance - June 2024

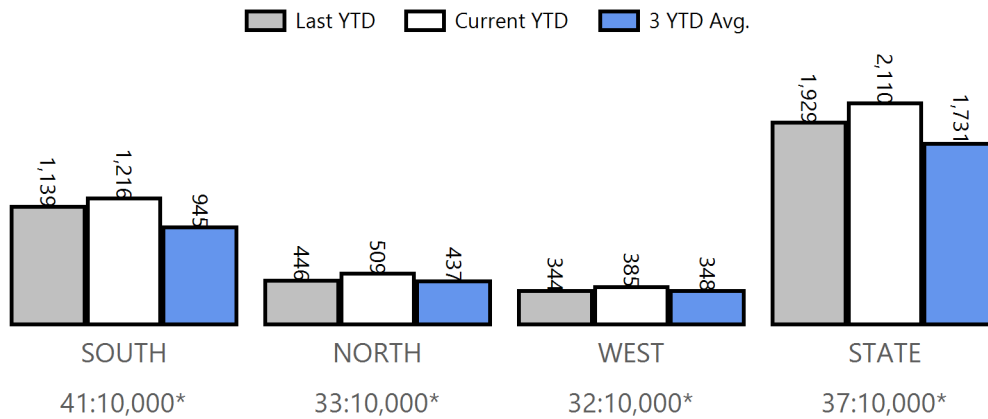
Public Order : Noise - June 2024

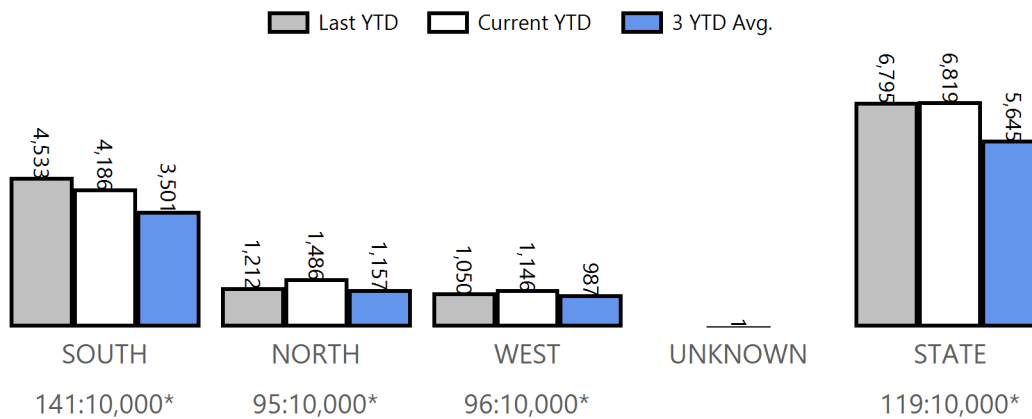
Public Order : Vandalism - June 2024

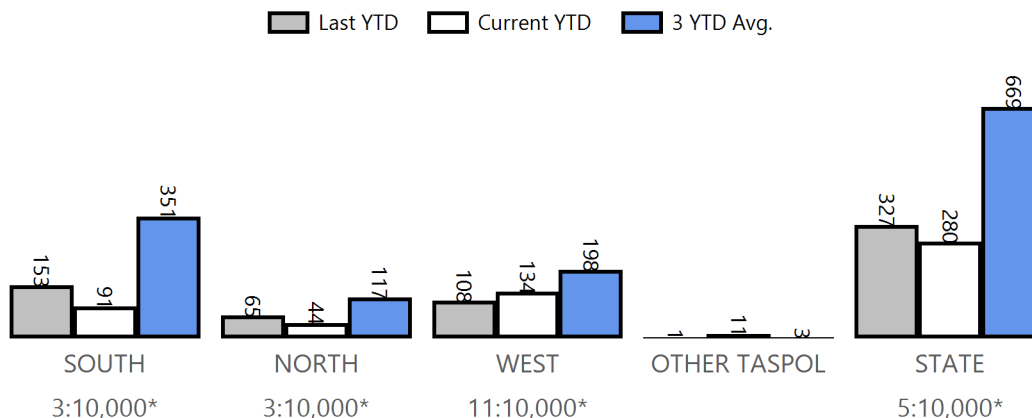
Public Order : Offensive Behaviour - June 2024

Liquor Infringement Notices - June 2024

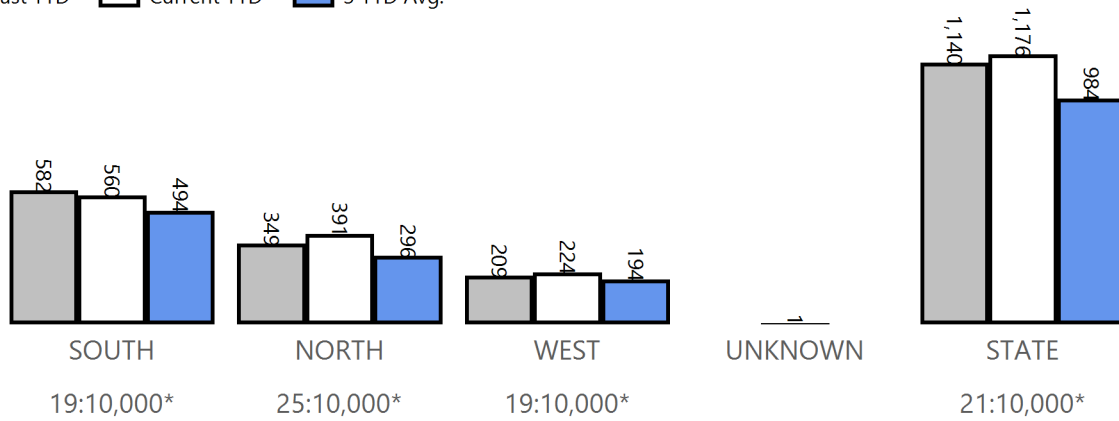

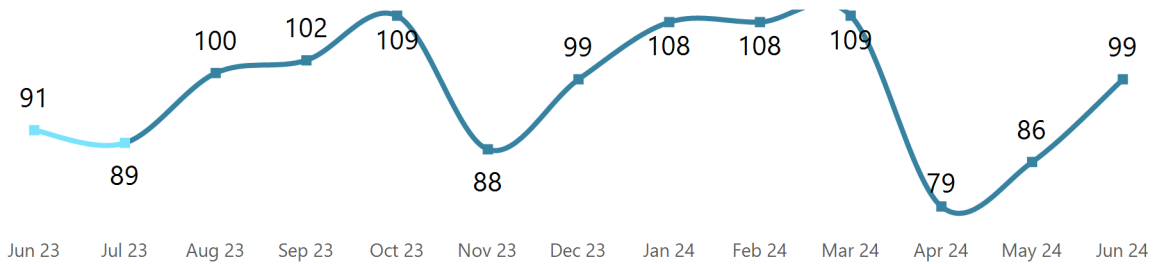

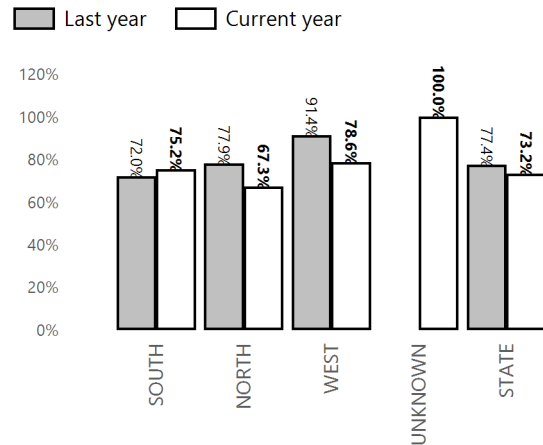

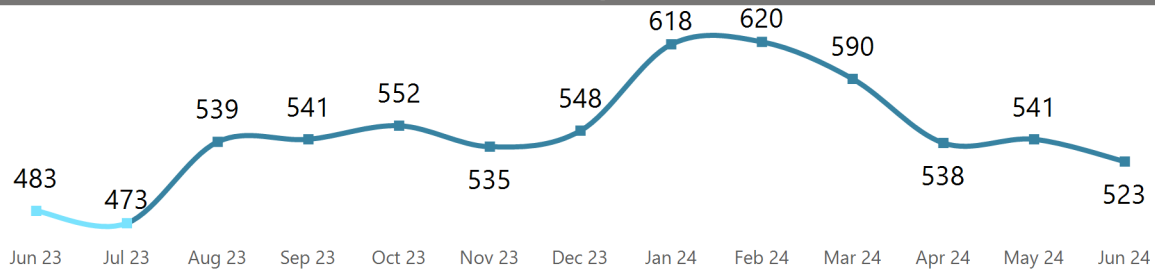

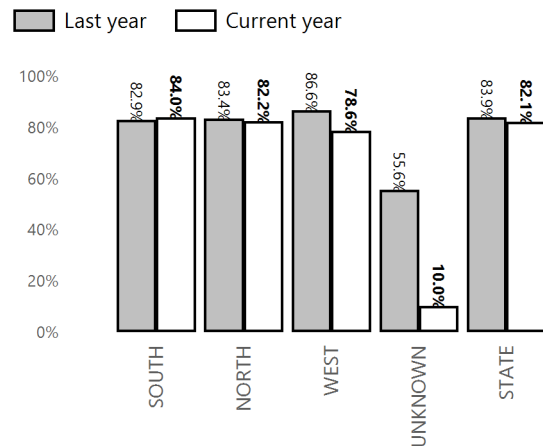

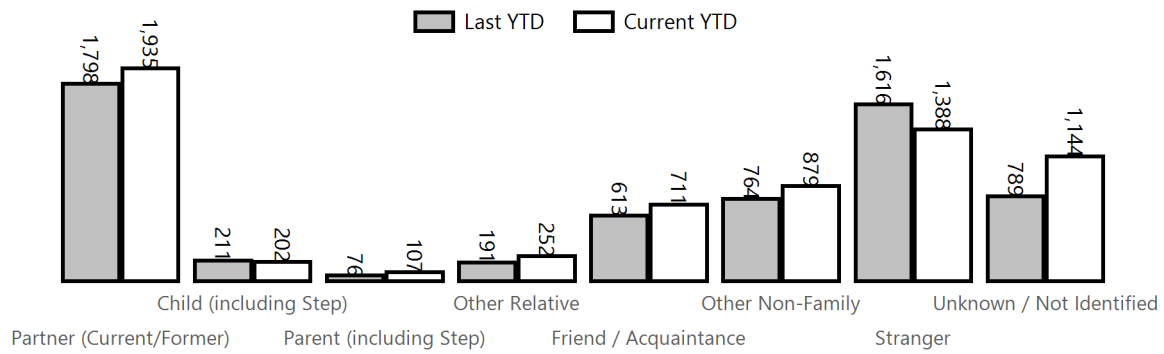

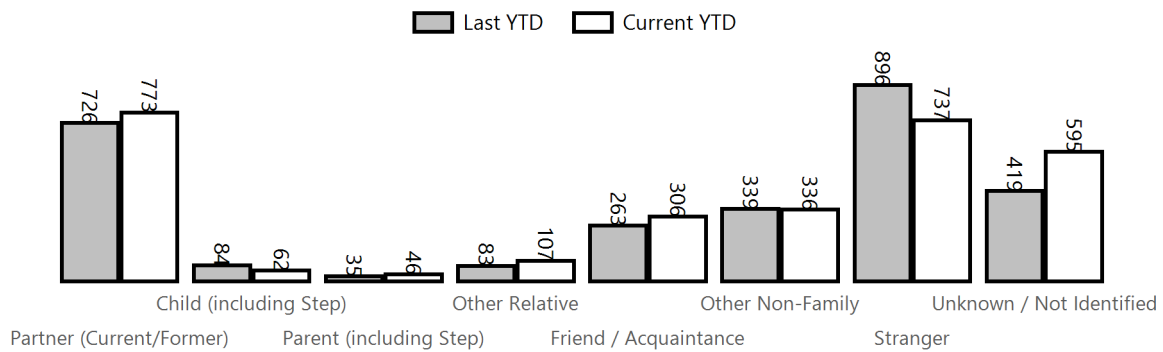

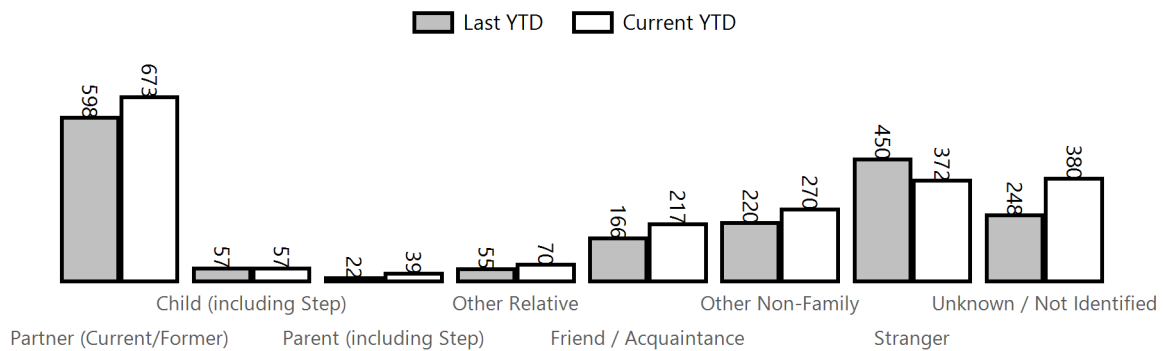

Total Person Offences - Victim Relationship - SOUTH



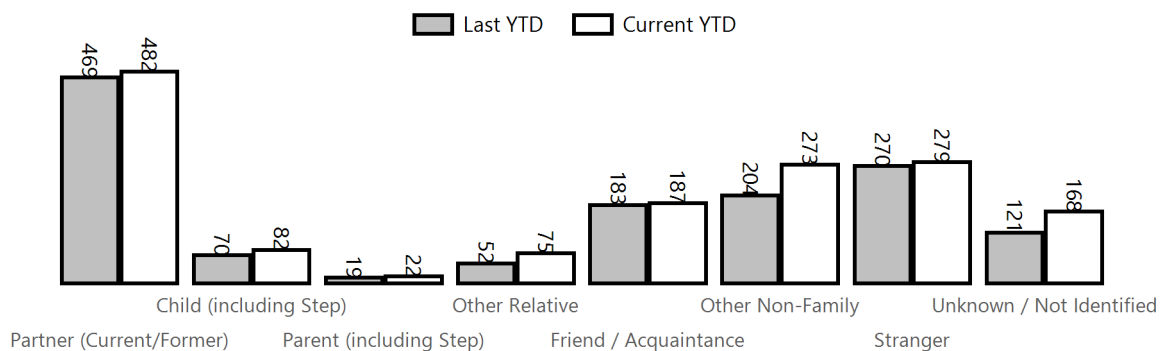

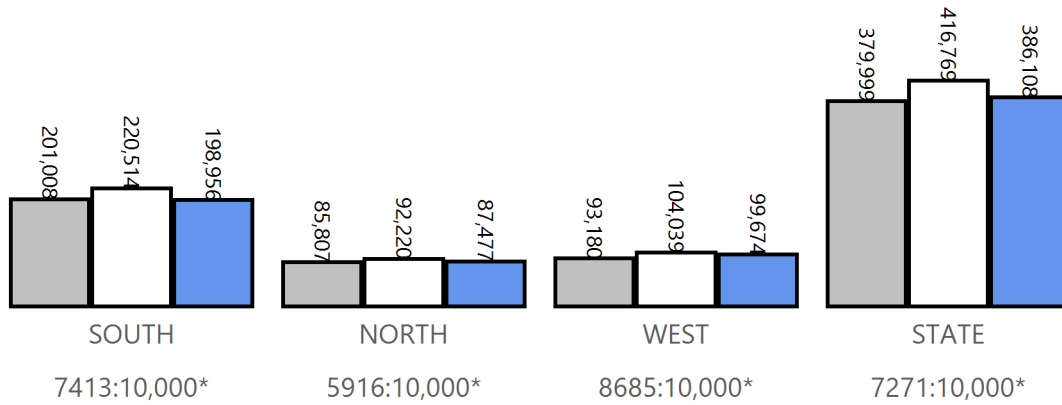

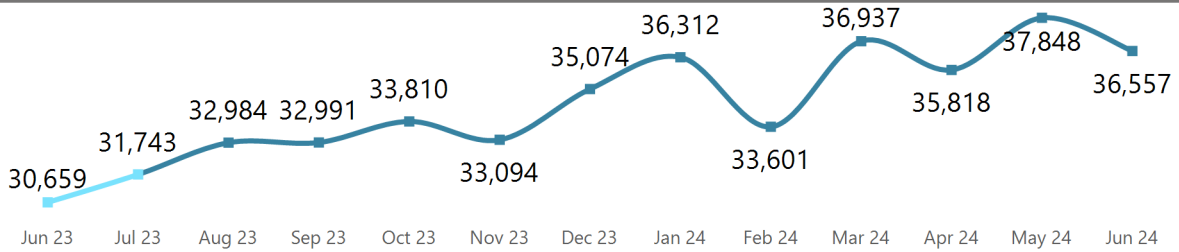
Uniform Police Patrol Hours - June 2024

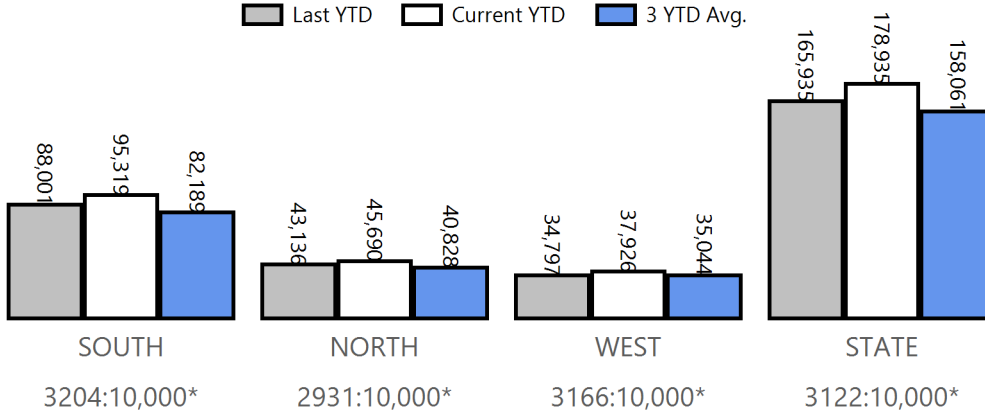
Uniform Police - Patrol Hours

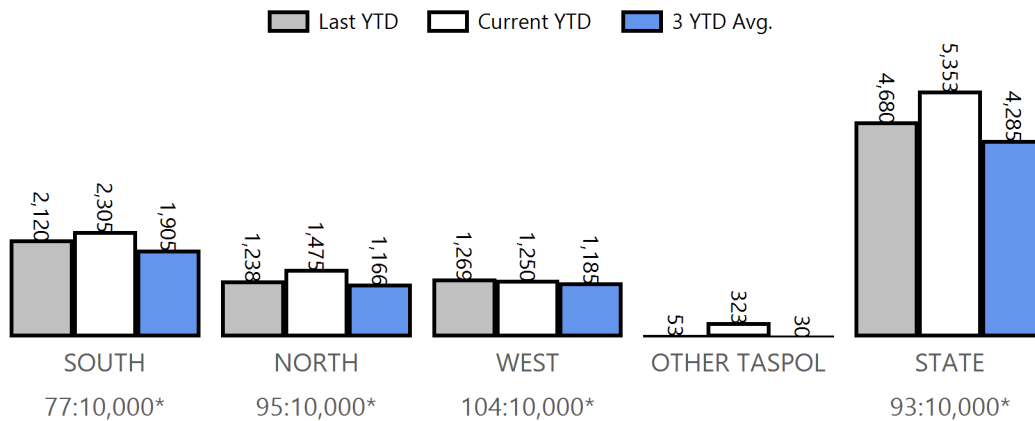

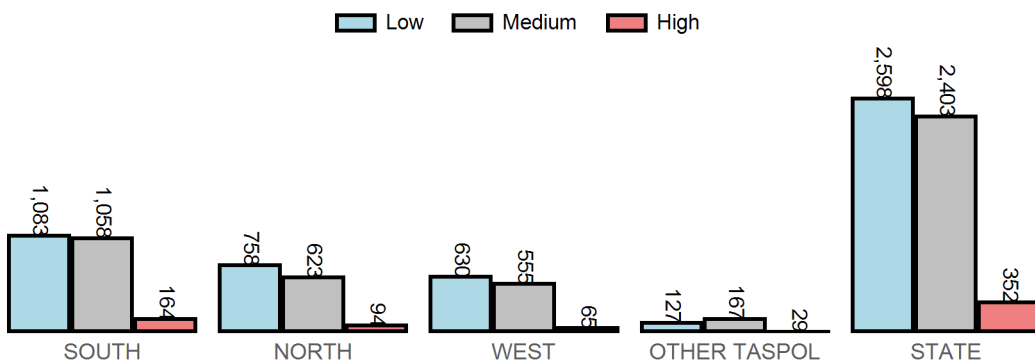
Family Violence Incidents - June 2024

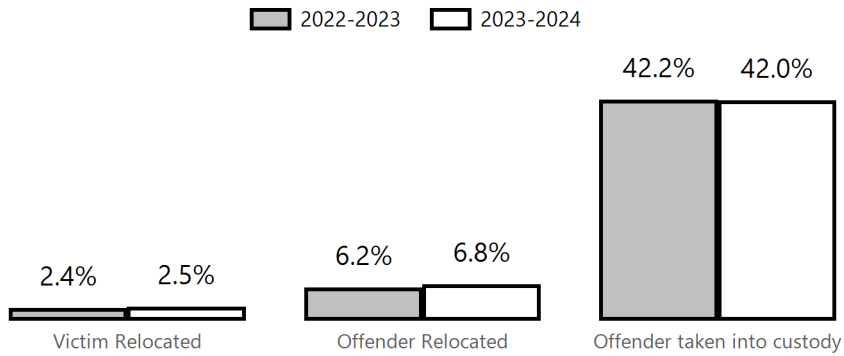

Family Violence RAST - Excludes Other and Argument Categories



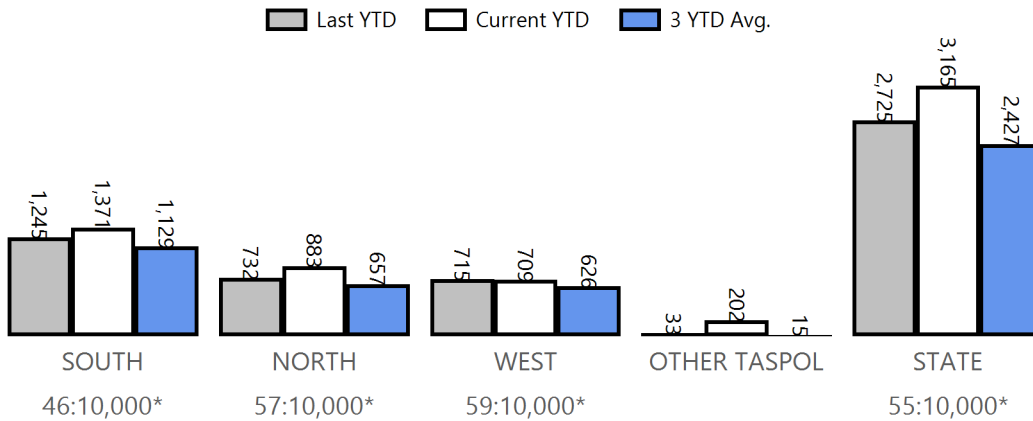

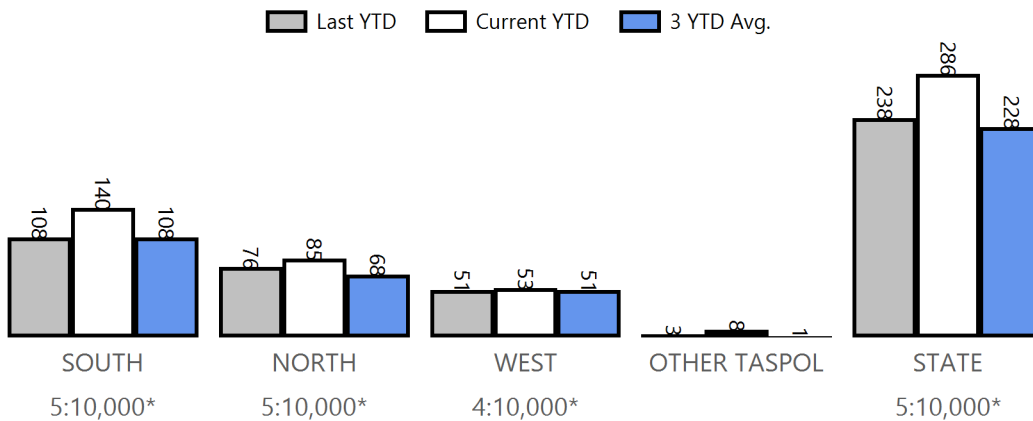
Family Violence Incidents with Child Witness - June 2024

Family Violence Incidents: Weapons Present - June 2024



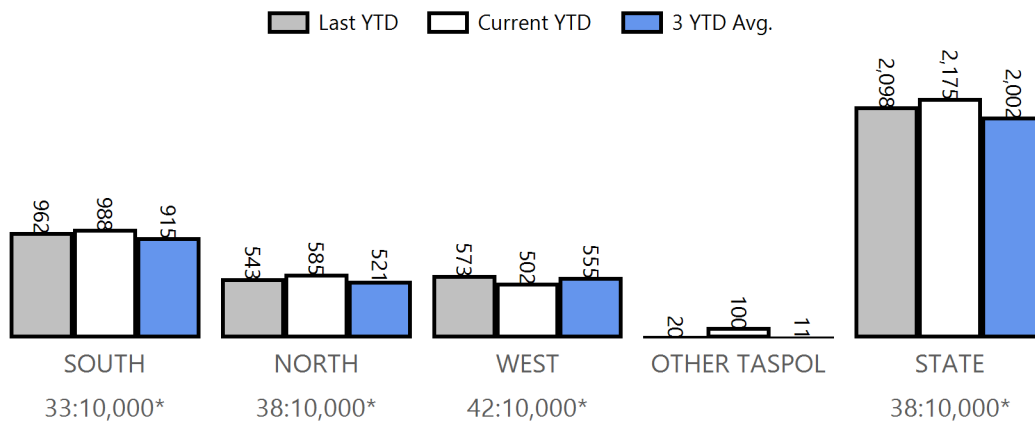

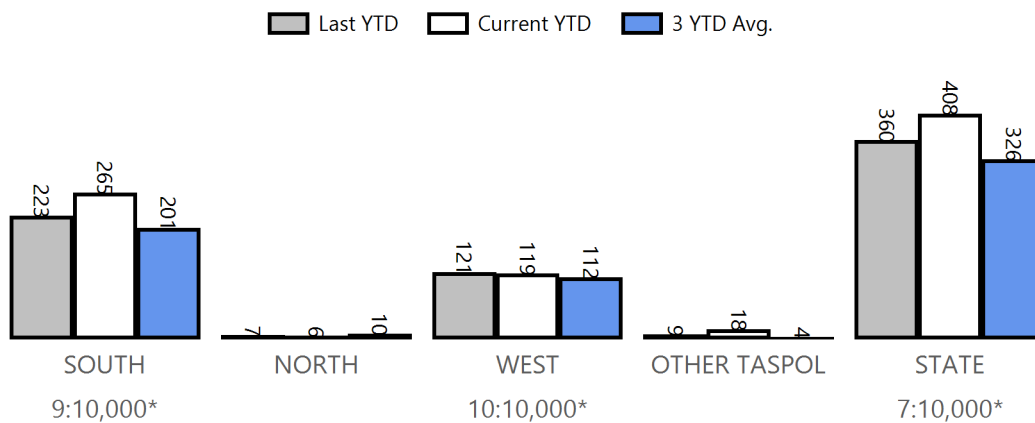
FV Incidents with Police FV Order Issued - June 2024

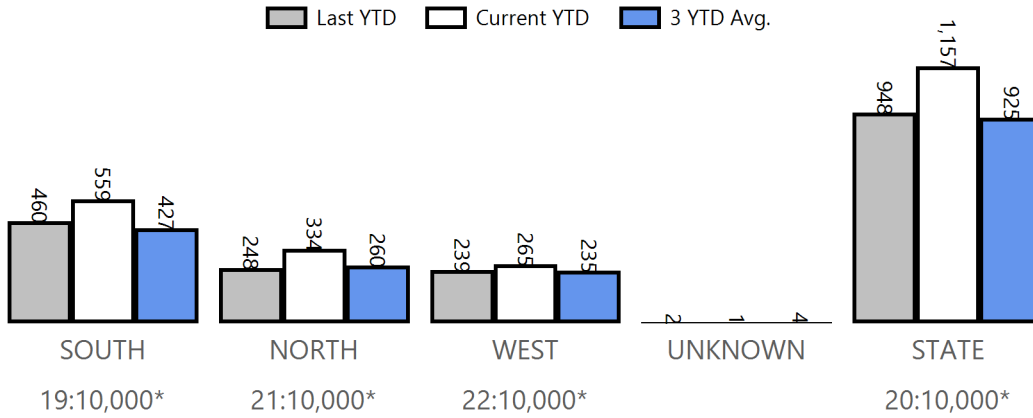
FV Incidents with FV Order Application - June 2024

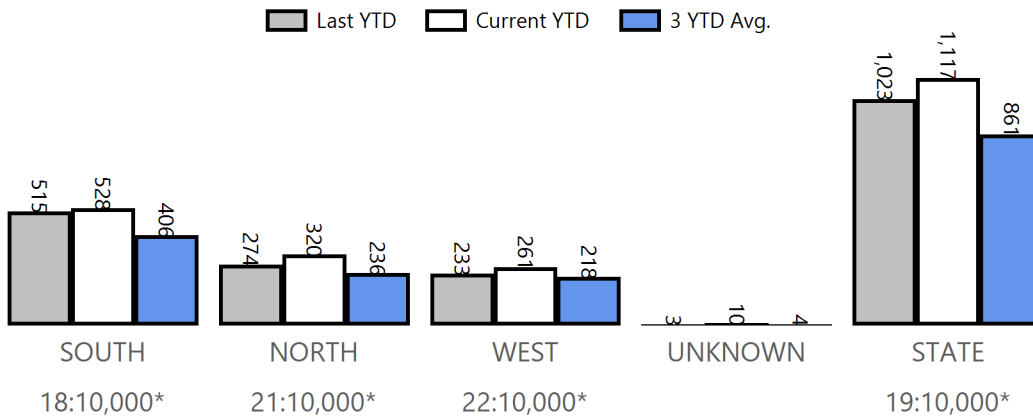
Breach of Police Family Violence Orders - June 2024

Breach of Family Violence Orders (excluding PFVOs) - June 2024

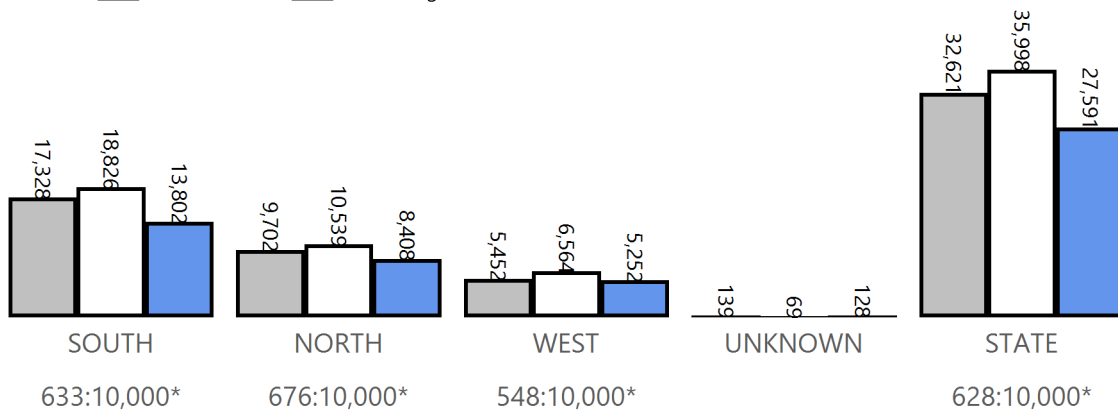

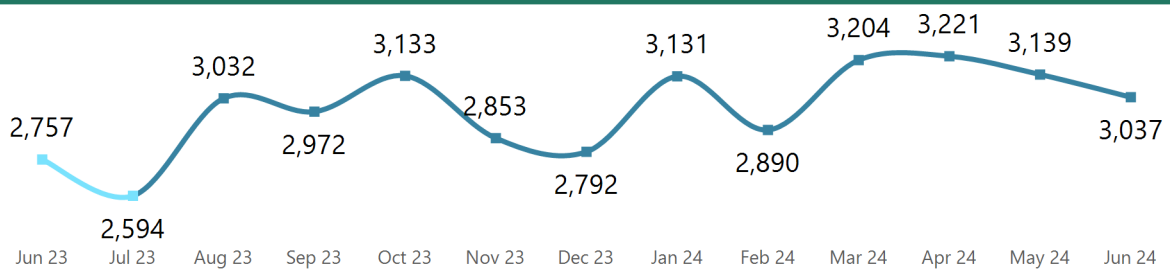

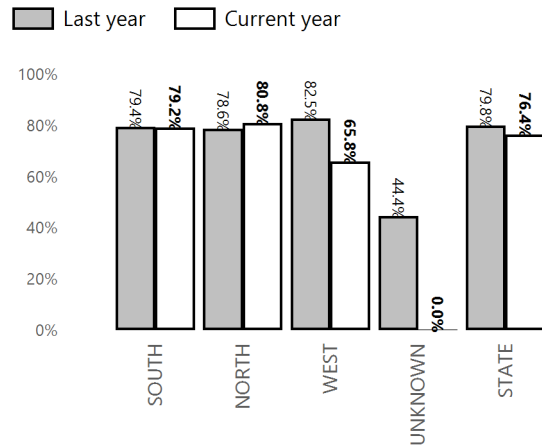

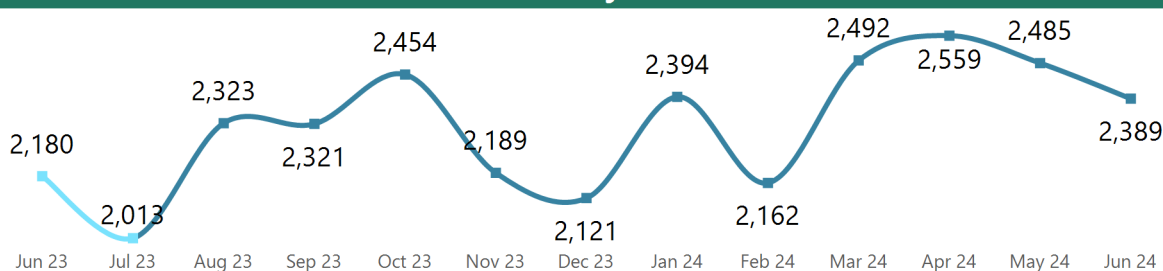

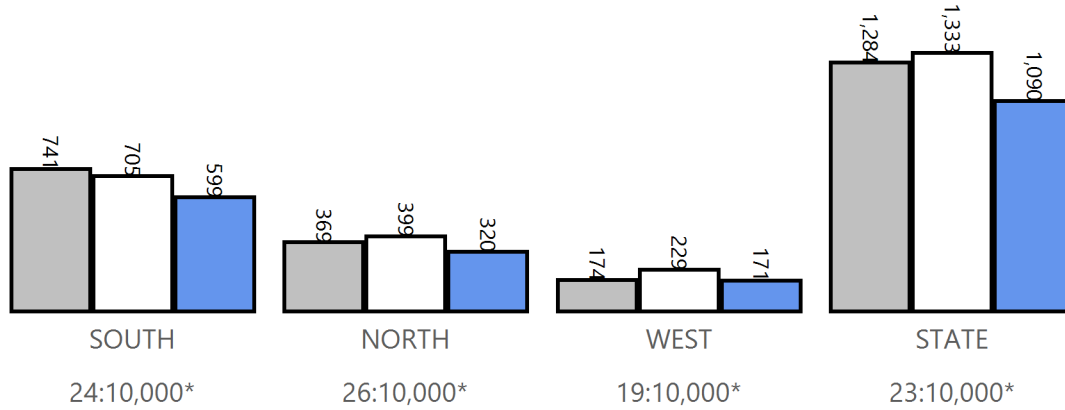

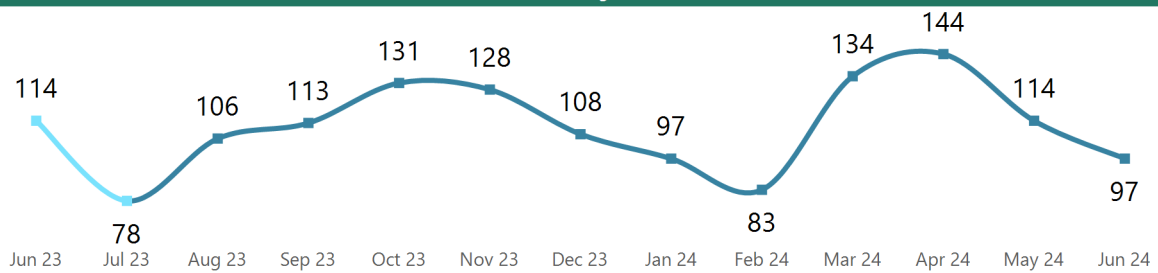

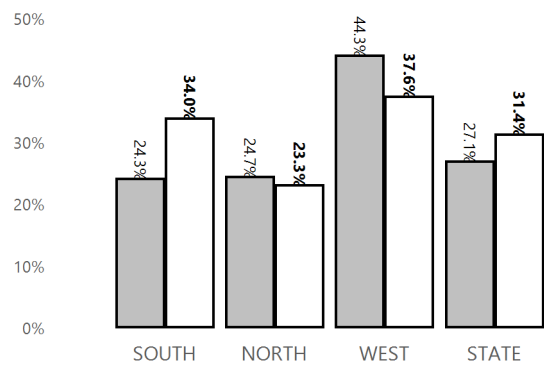

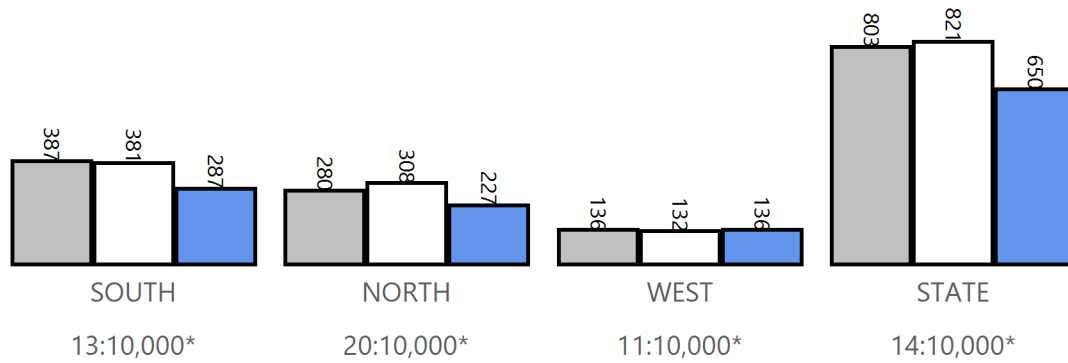

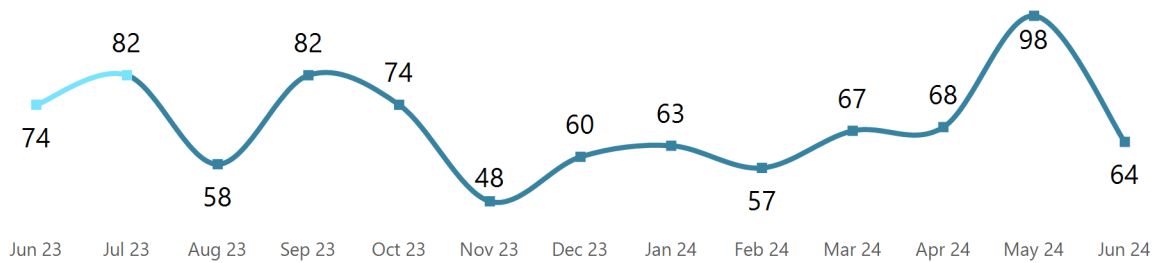

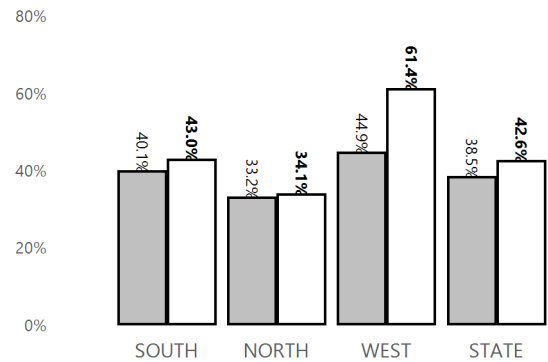

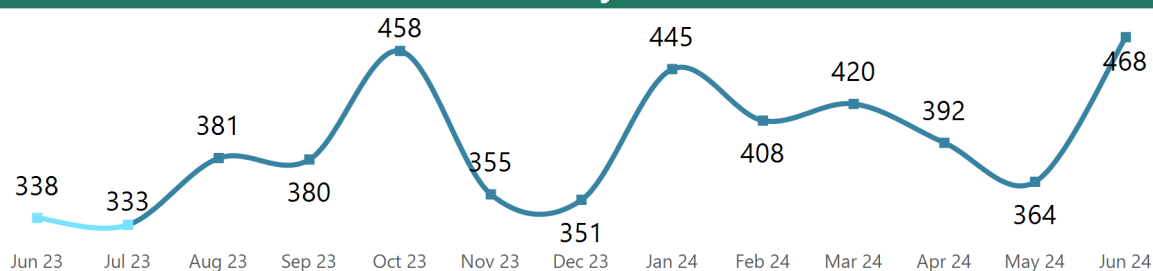

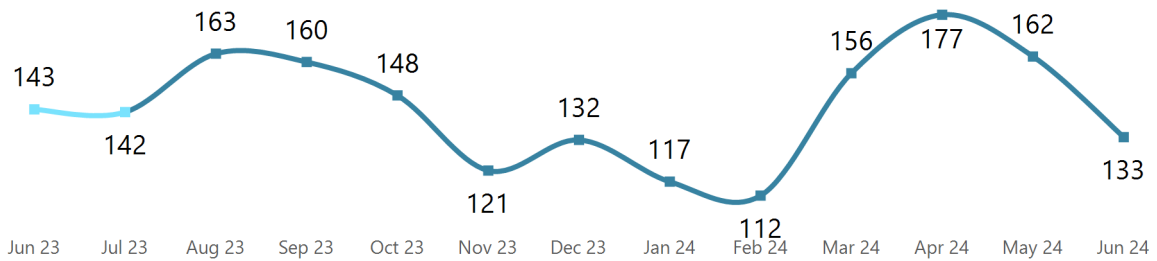

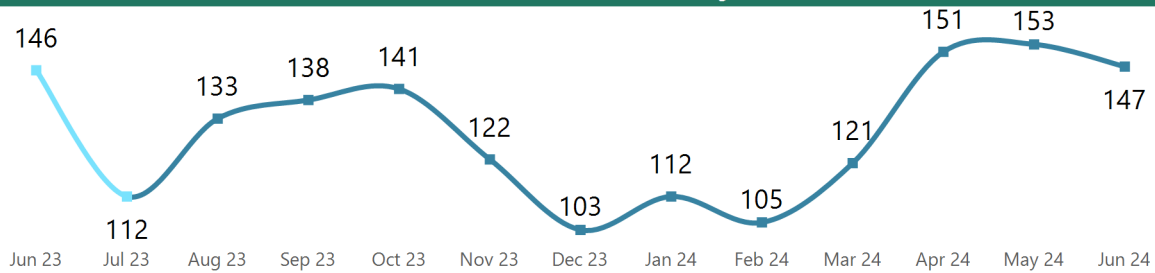

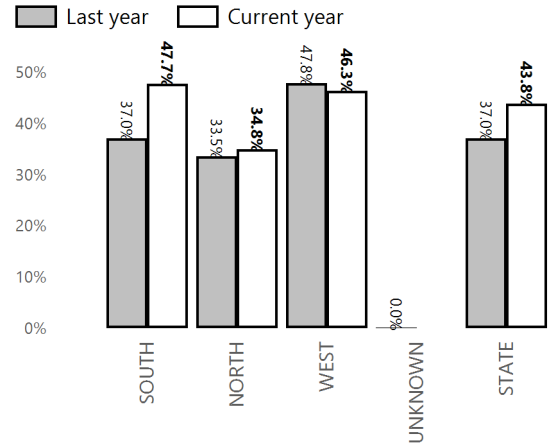

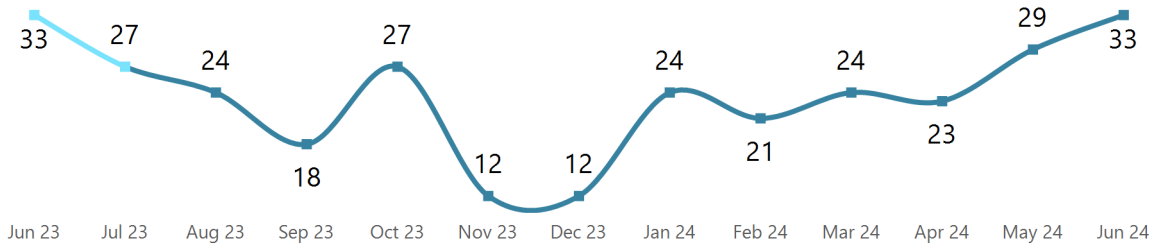
SMV : Recovered Fire Damaged - June 2024

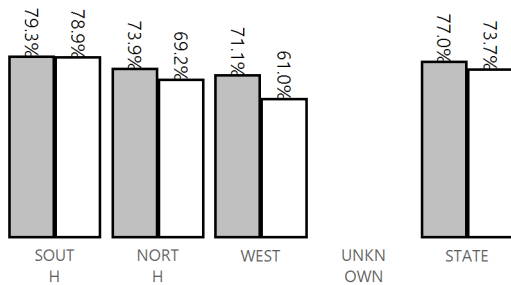

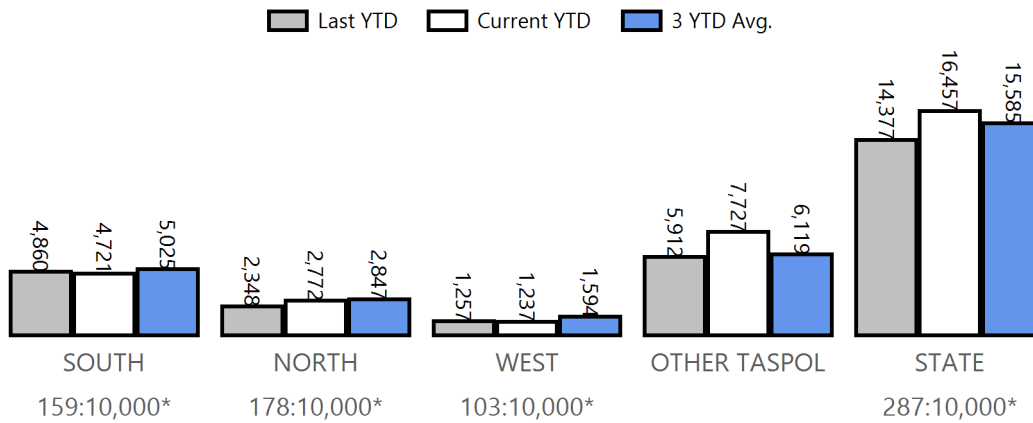

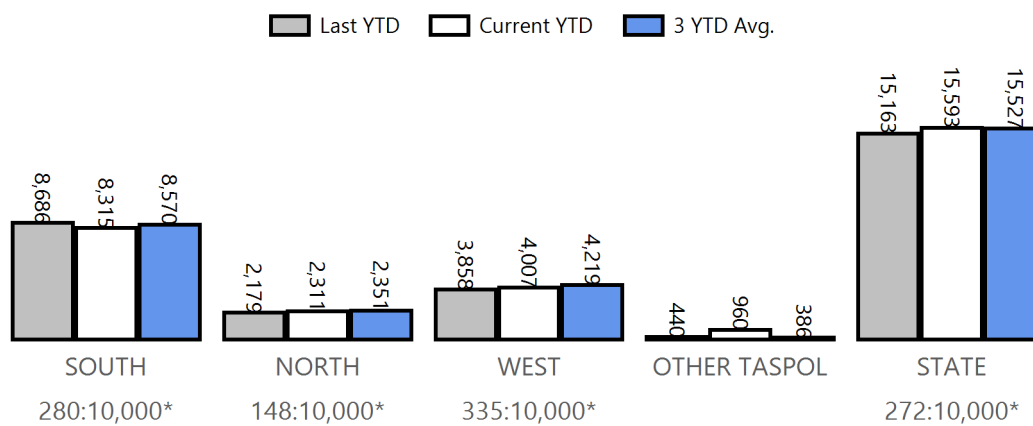
Intelligence Submission Occurrences - June 2024

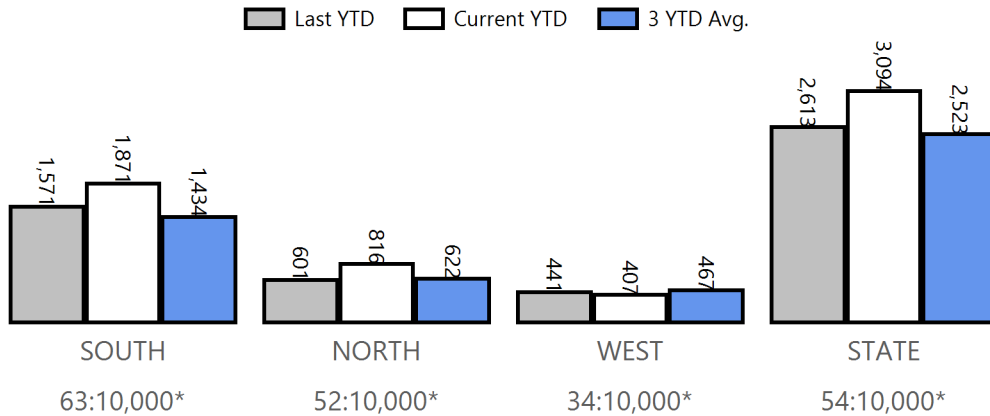
Street Check Occurrences - June 2024

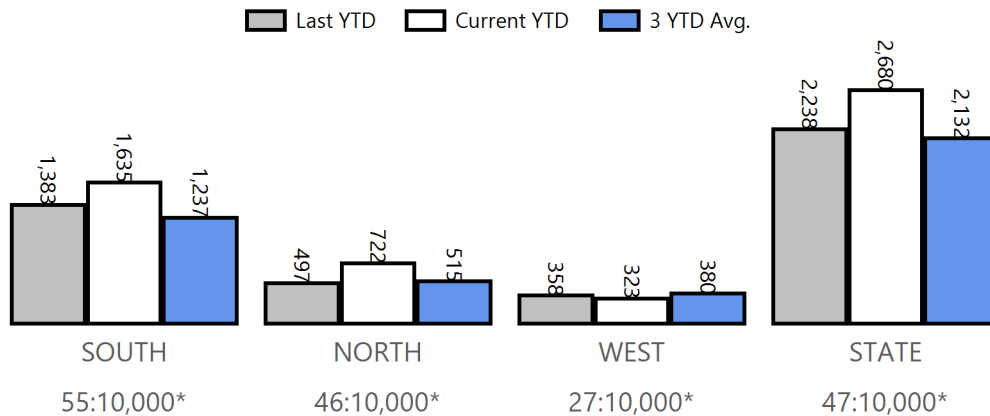
CIB: Total Offenders - June 2024

CIB: Total Crime Offenders - June 2024



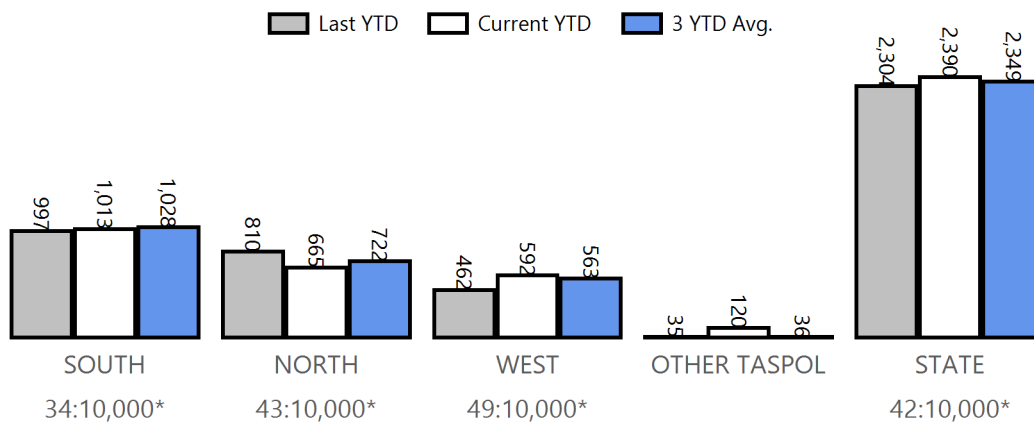

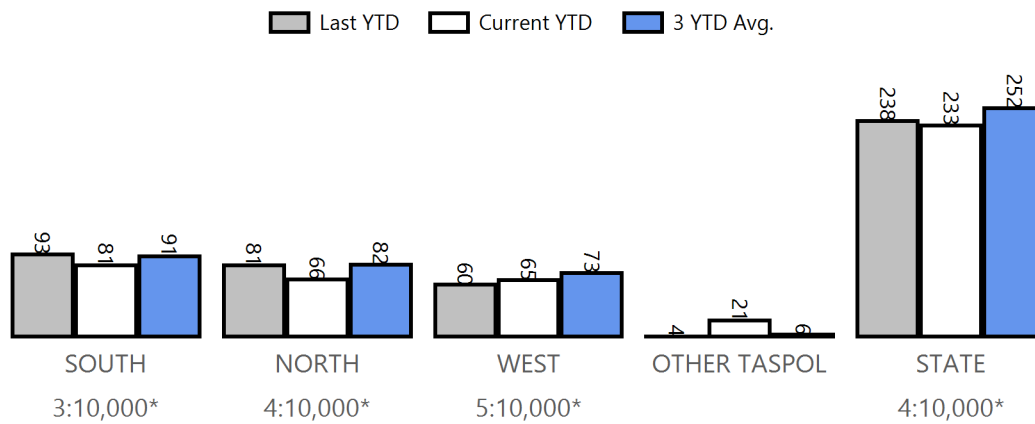

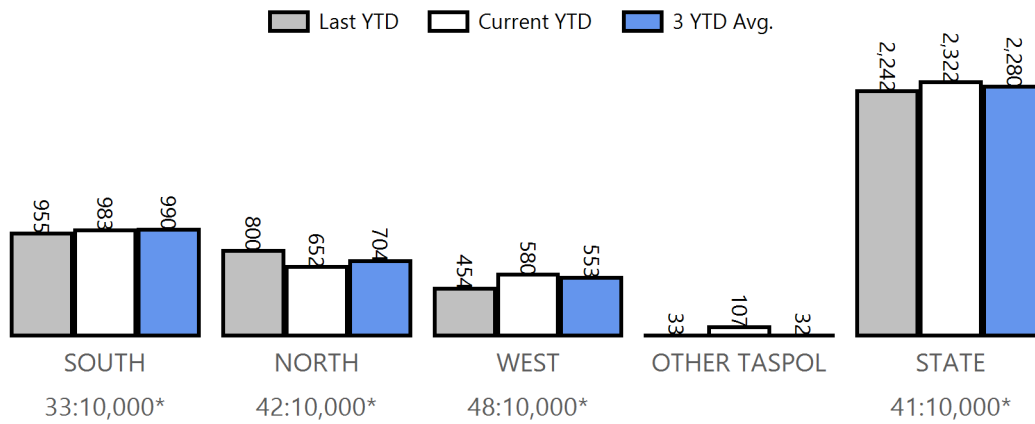

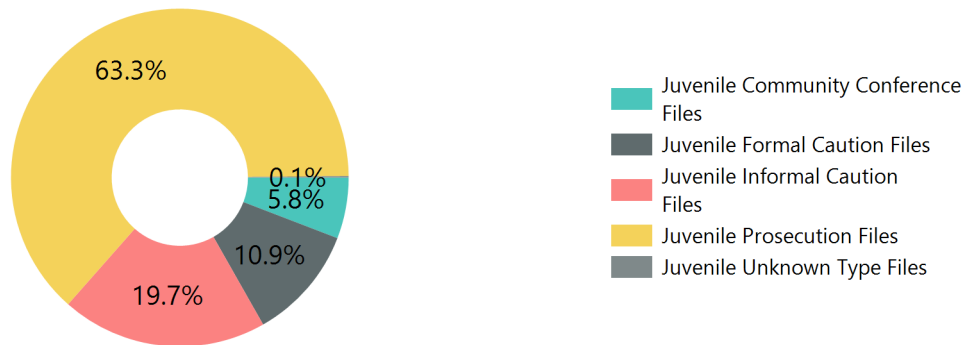

Total Traffic Offenders - June 2024



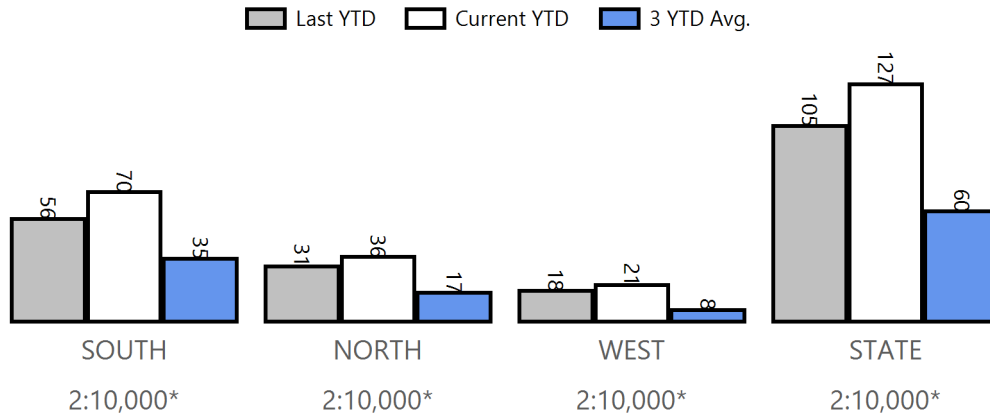

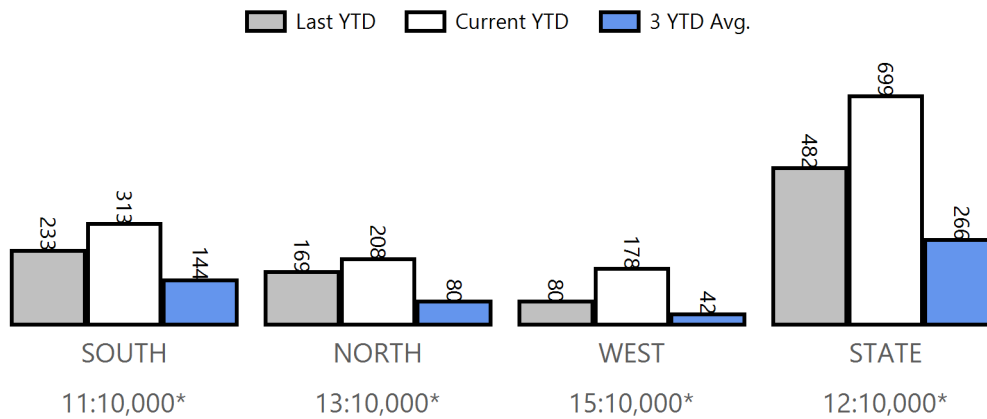
Major Static District Traffic Operations - June 2024

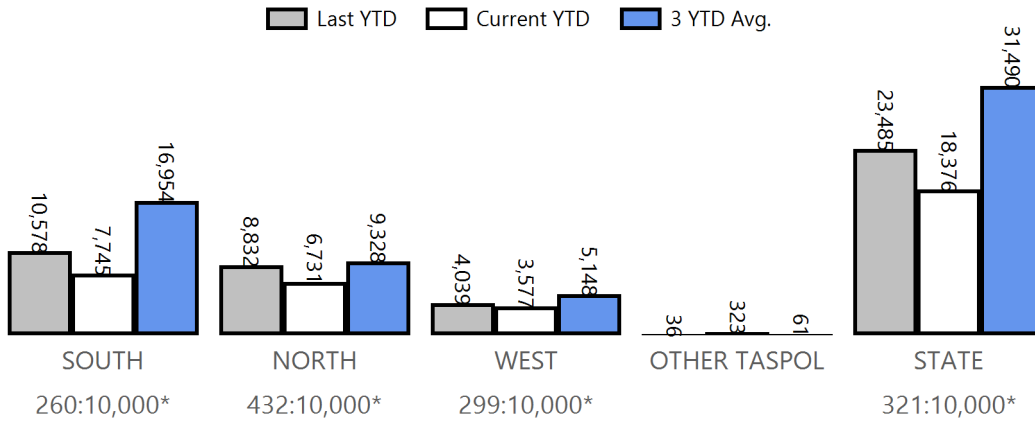

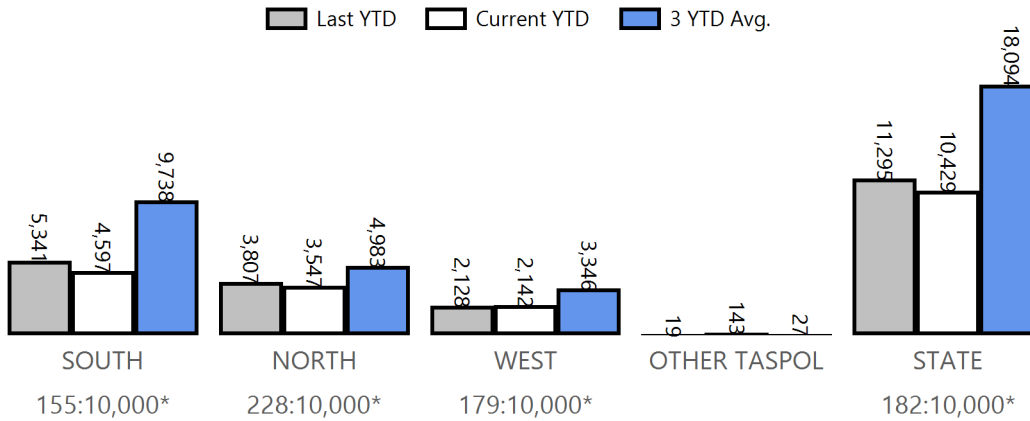
Speeding Offenders - June 2024

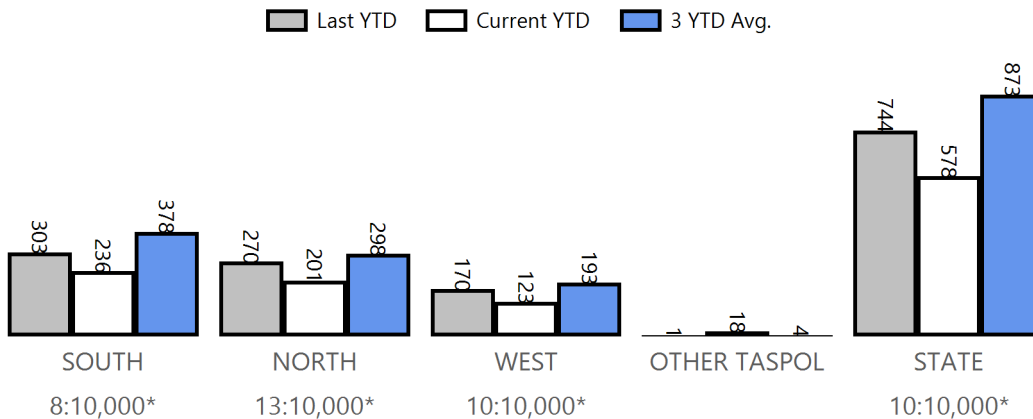
Speeding 15-29 km/h Offenders - June 2024

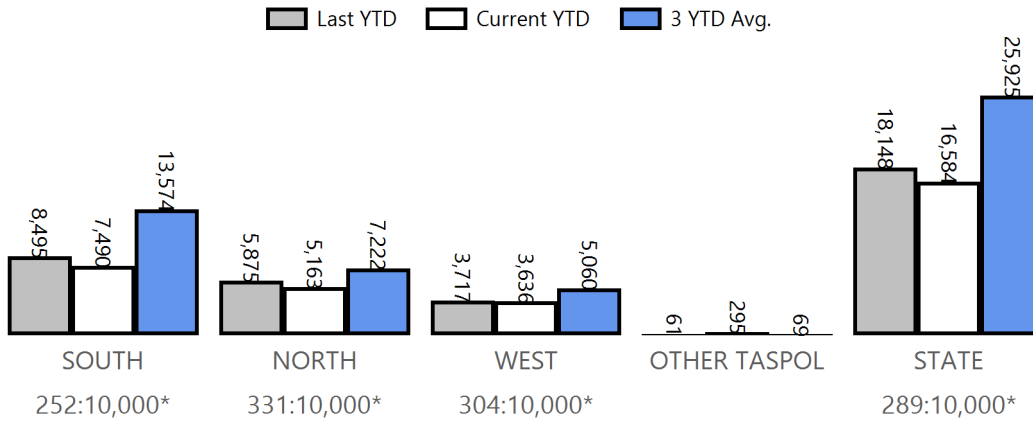
Speeding 30+ km/h Offenders - June 2024

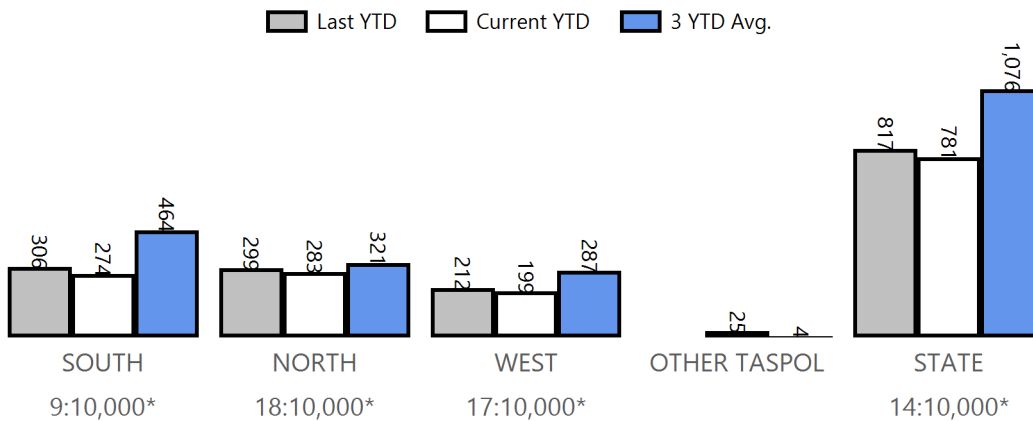
High Risk Traffic Offenders - June 2024

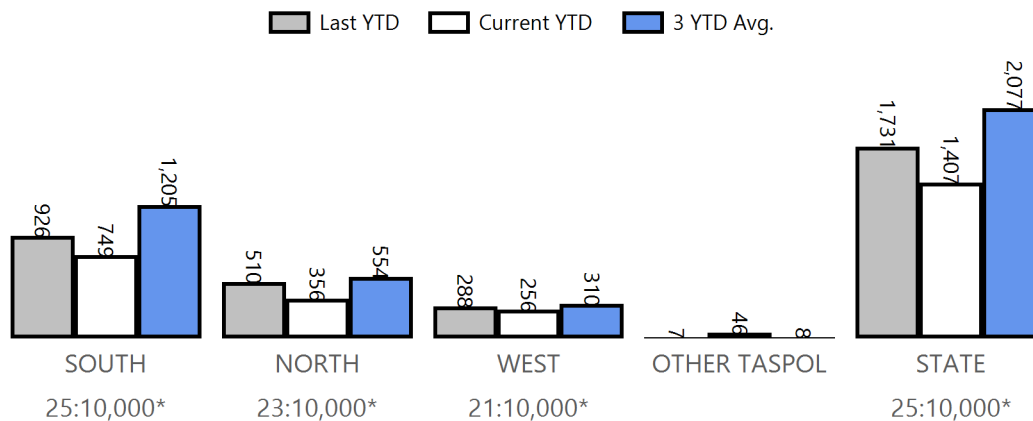
Seatbelt Compliance Offenders - June 2024

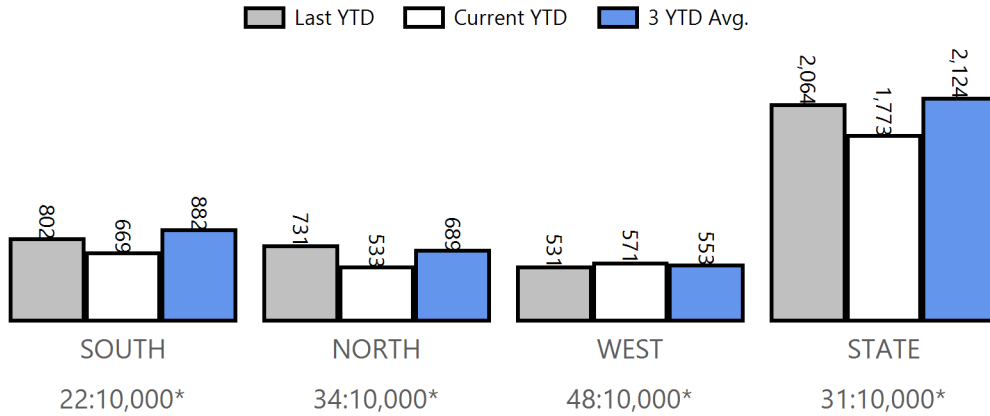
Mobile Phone Offenders - June 2024

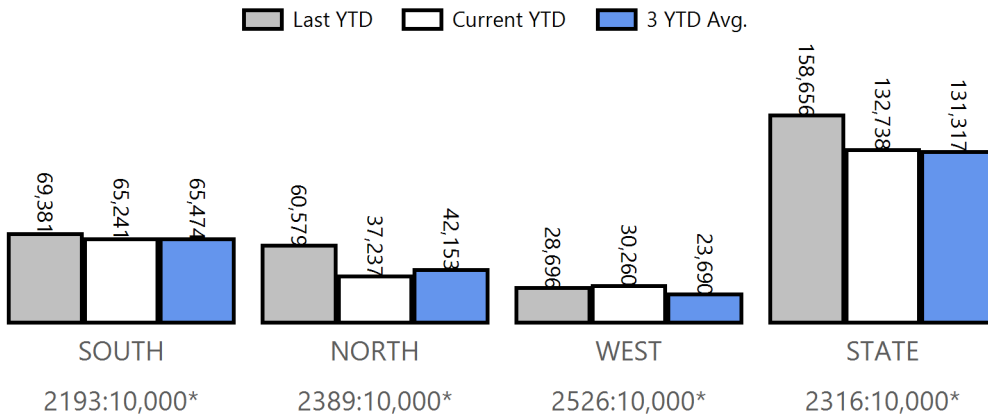
Vehicle Defect Notices - June 2024

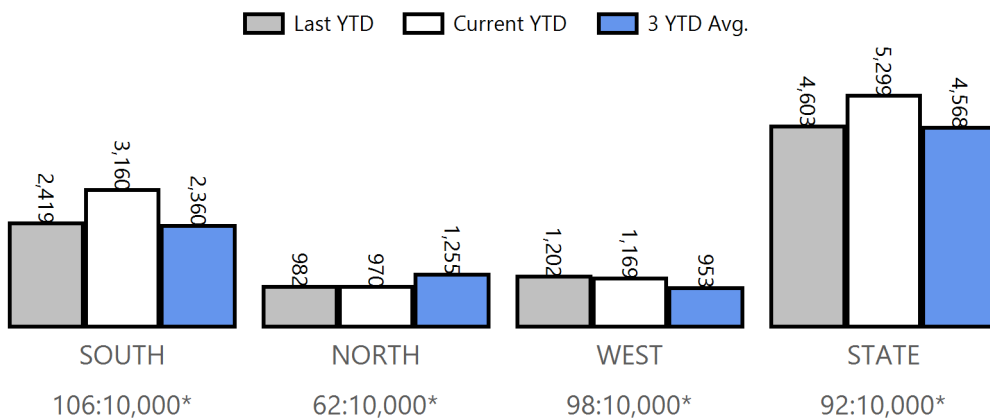
Random Breath Tests (Alcohol) - June 2024

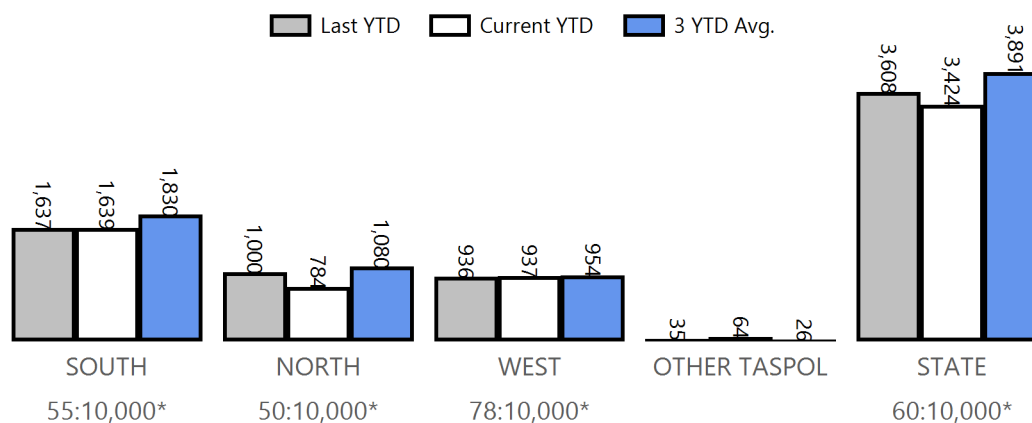
Oral Fluid Tests (Drugs) - June 2024

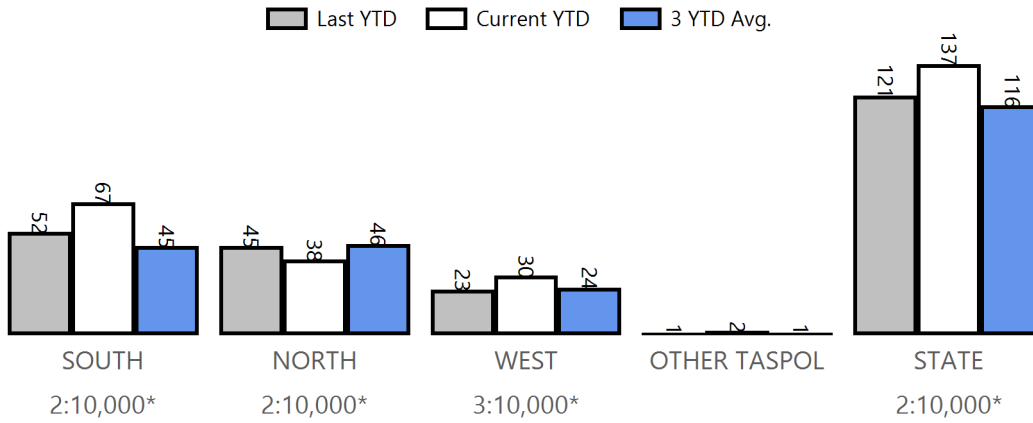

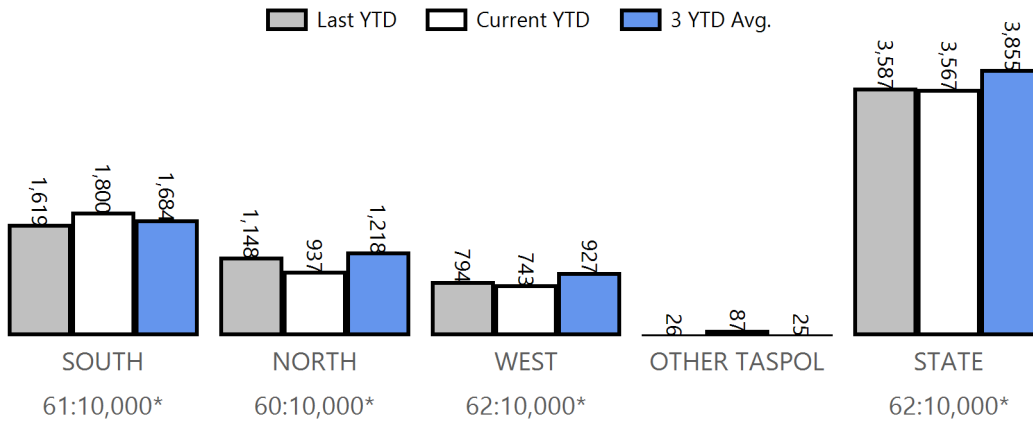
Dangerous and Reckless Driving Offenders - June 2024

Disqualified and Unlicensed Driving Offenders - June 2024



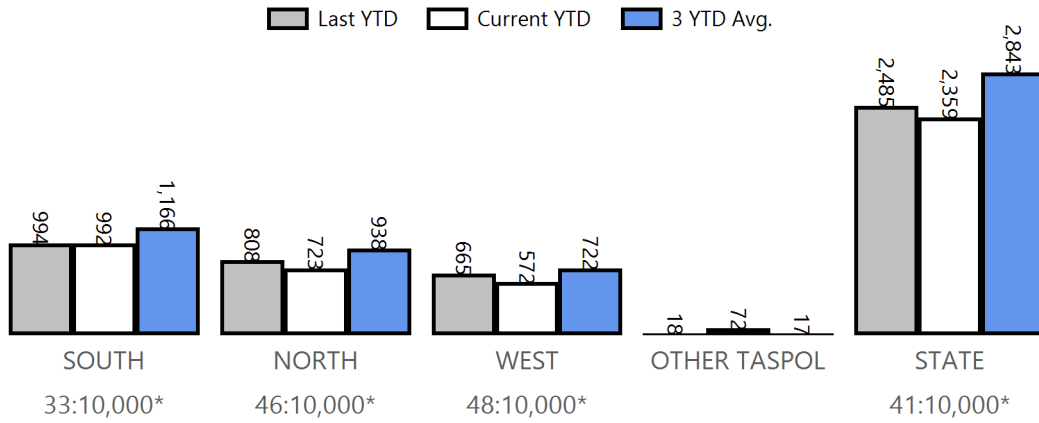

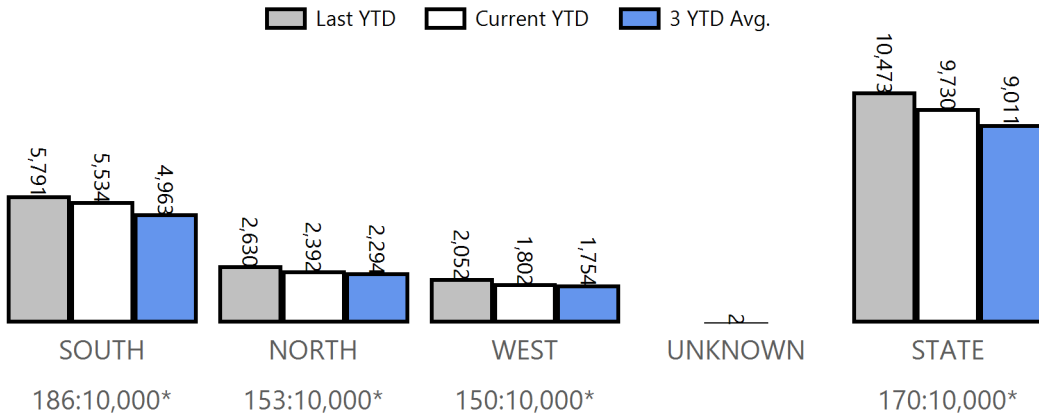
Unregistered Vehicle Offenders - June 2024

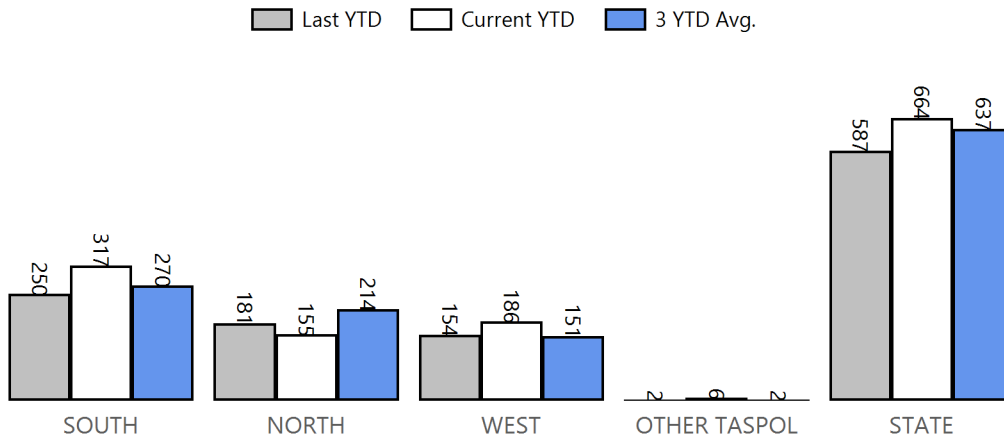
Vehicle Complaint Dispatch Incidents - June 2024

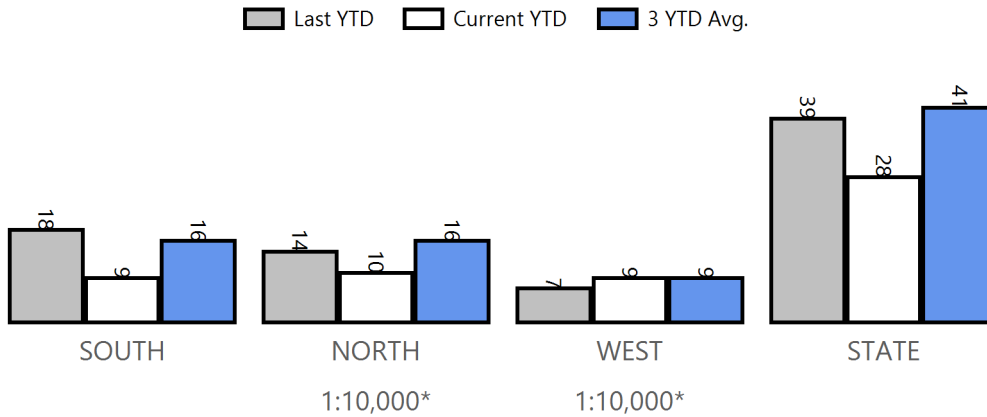

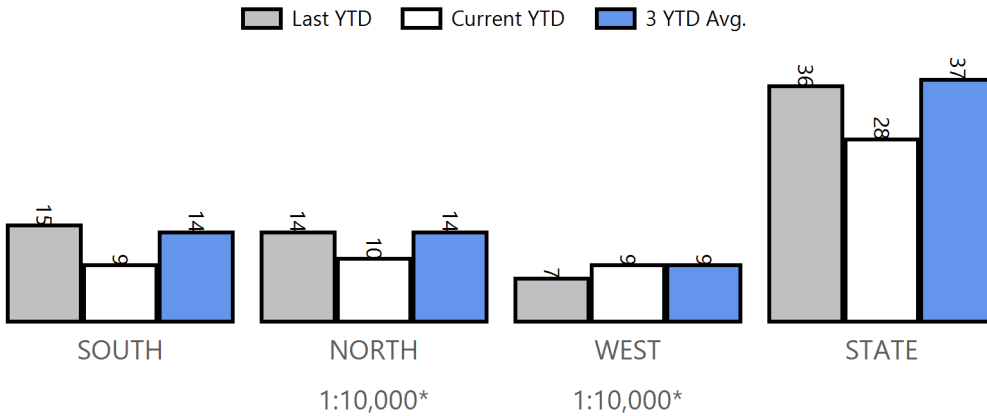

Crash Fatalities - June 2024



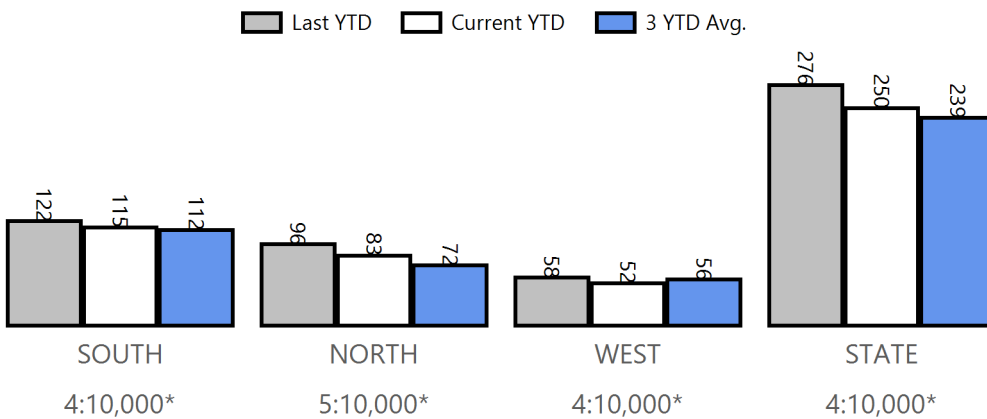

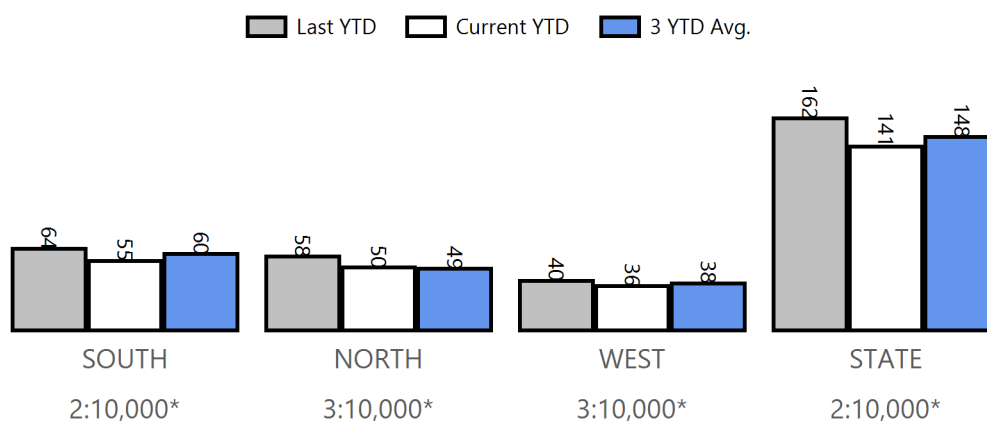

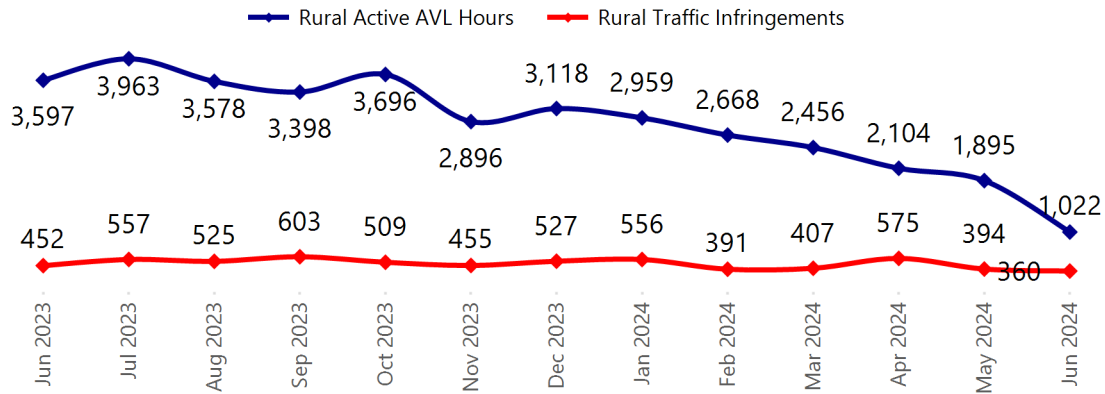
On Road Fatal and Serious Crashes in Rural Areas - June 2024



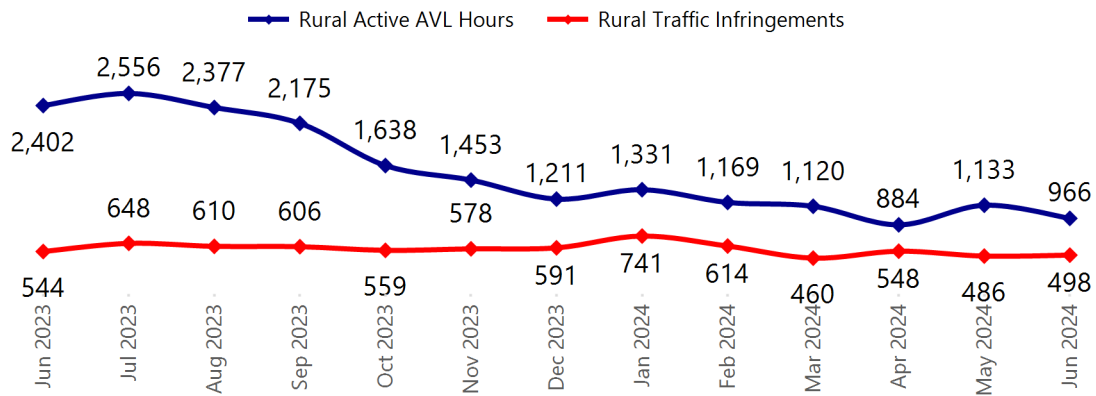

Total Marine Offenders - June 2024

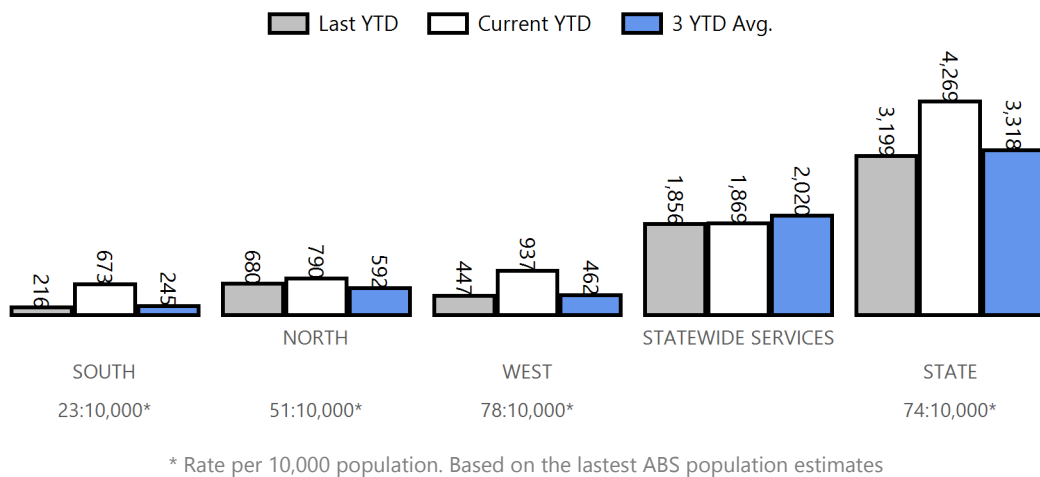


Sea Inspections (Vessel & Non-Vessel) - June 2024



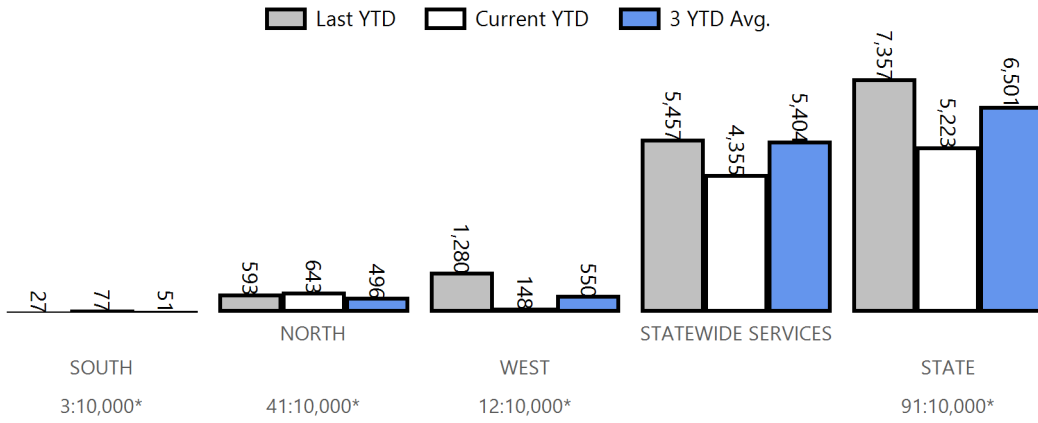
