QUESTION TIME BRIEF

MINISTER FOR POLICE, FIRE AND EMERGENCY MANAGEMENT

Subject:	Budget savings strategies	
Current as at:	30-July-2024	

KEY MESSAGES:

- As part of the Whole of Government Budget Efficiency Dividend, DPFEM has a budget savings requirement of \$35 million over four years.
- DPFEM has been working with Treasury and my office on this issue, and in advance of the handing down of the State Budget, it has commenced working on a budget strategy to determine the specifics of how the savings will be achieved.
- Frontline service delivery positions such as police officers and fire fighters are excluded from the budget savings requirement.
- Staff wellbeing is front of mind and the DPFEM Executive will work through this task in a strategic way that recognises the value of its people and the work that they perform.

TALKING POINTS:

- 80% of DPFEM's costs relate to employee salary costs, and it is acknowledged this will need to be a primary focus in order to achieve the required savings.
- DPFEM will seek to minimise the impacts of change through the development of clear strategies and direct communication with our staff and relevant employee representative organisations.
- As DPFEM develops its strategy over the coming months, existing expenditure will be managed through its Executive

Committee, Budget Oversight Committee and Vacancy Control Committee.

 DPFEM have received representations from the CPSU on behalf of their members at Forensic Science Service
 Tasmania and will meet with the CPSU after the State
 Budget is delivered on 12 September 2024.

Q&A:

Will the budget savings strategy involve forced redundancies?

The actions to implement any approved strategies have not been determined. At this stage, there is no intention for forced redundancies. Natural employee attrition will be a focus and future vacancies will be assessed on a case-by-case basis, as currently occurs through the Vacancy Control Committee in alignment with approved strategies.

Will there be less police on our streets because they are undertaking administrative duties?

Recruit of more Police Officers is a key priority and will continue to occur. Strategy development to address budget efficiencies will examine how DPFEM works and initiatives to improve business systems, processes and decision making. It is about challenging the status quo and making considered decisions moving forward.
